Patent Advisory Committee Recommendations – Delegation of Authority

No. 4-2015

- WHEREAS, Ohio law and the Bowling Green State University (BGSU) Academic Charter make the creation and dissemination of knowledge and the commercialization of patents that result from that knowledge important functions of Bowling Green State University; and
- WHEREAS, an external analysis of the potential commercial value of the BGSU intellectual property portfolio was performed by Tremonti Consulting, LLC ("Tremonti"); and
- WHEREAS, these findings were submitted to the BGSU Patent Advisory Committee (PAC) for their recommendation, in accord with the University Patent Policy; and
- WHEREAS, Ohio law vests in the Board of Trustees the responsibility and delegable authority to retain, assign, license, transfer, sell, or otherwise dispose of, in whole or in part and upon such terms as the Board of Trustees may direct, any and all rights to, interests in, or income from any such discoveries, inventions, or patents which the university owns and to direct any and all income or proceeds derived

or retained from such dispositions to the general or special use of the University; and

WHEREAS, successful commercialization requires the President and her delegees to have the authority to negotiate and finalize agreements for patents in a timely and efficient manner; and

NOW, THEREFORE BE IT RESOLVED, by the Bowling Green State University Board of Trustees as follows:

- (1) Pursuant to the authority granted to it under Ohio law, the Bowling Green State University Board of Trustees hereby delegates to the University President the authority and discretion to retain, assign, license, transfer, sell, or otherwise dispose of University owned patents contained in Tremonti's external analysis and, in whole or in part and upon such terms and with such parties, if any, as the President determines to be in the best interests of the University.
- (2) Under this delegation of authority the President or the President's delegee may execute all documents necessary to complete such transactions.
- (3) The Board further delegates to the University President the authority to direct any income or proceeds that may be derived or retained from such dispositions to the general or special use of the university as the President may determine to be in the best interests of the University.

Ms. Montgomery presented an item proposing that:

that the Bowling Green State University Board of Trustees approves an amendment to Article IV.F.1. of the Academic Charter.

Ms. Montgomery moved and Mr. Primrose seconded that the above four action items from the Academic and Student Affairs Committee be approved. The Board Secretary conducted a roll call vote with the following results: Voting "yes" – Mr. Daley, Mr. Keller, Mr. Levey, Ms. Montgomery, Ms. Morrison, Ms. Newlove, Mr. Primrose, and Mr. Voll. The motion was approved with eight affirmative votes.

Ms. Montgomery reported that the committee also heard several updates from Dr. Rogers and Vice President Carr on activities and initiatives in Academic and Student Affairs: (1) BGSU's ranking in the top one hundred public universities in *US News and World Report*; (2) academic strategies to maintain historic strengths and build new programs for the future; (3) expansion of enrollment to new undergraduate and graduate populations (international students, transfer students, professional master's programs, and accelerated bachelor's/master's programs); (4) retention rates of first-time, full-time students; (5) student affairs role in retention and student success; and (6) additional dashboard metrics.

FINANCIAL AFFAIRS/FACILITIES COMMITTEE

Ms. Newlove reported that the Financial Affairs/Facilities Committee had met had two items for Board consideration.

Authorization of Amendment of Bowling Green State University's Section 125 Cafeteria Plan for Employees

No. 6-2015

WHEREAS, Bowling Green State University provides its employees and dependents with access to health insurance, and;

WHEREAS, each employee must contribute to the benefit plan, and;

WHEREAS, health care spending by employees and the University is significant and continues to rise, and;

WHEREAS, Section 125 of the Internal Revenue Code authorizes public sector employers like BGSU to

- establish Section 125 plans, which are also known as "cafeteria plans", and;
- WHEREAS, BGSU has established such a cafeteria plan which allows BGSU employees and the University to save the cost of certain taxes, including payroll taxes, by allowing employees to pay for certain qualified health care and child care expenses on a pre-tax basis, and;
- WHEREAS, recent changes to best practices and federal law make it advisable for BGSU to implement amendments to the existing Section 125 plan as outlined more fully in the background statement provided to the Board;
- NOW, THEREFORE BE IT RESOLVED, that the Board of Trustees of Bowling Green State University authorizes the President, the Vice President for Finance and Administration, and the Chief Human Resources Officer of the University to take such actions as they deem necessary to amend the BGSU Section 125 Cafeteria Plan for the University's employees, in accordance with provisions of Section 125 of the Internal Revenue Code.

Approval of Bowling Green Campus - Landscape and Civic Structure Master Plan

No. 7-2015

WHEREAS, the proposed Bowling Green Campus - Landscape and Civic Structure Master Plan included important key design principles; and

WHERAS, the key design principles are:

- 1. Keep the landscape simple and elegant
- 2. Respect maintenance demands of the campus environment
- 3. Maximize return-on-investment of campus improvements
- 4. Keep materials and components consistent
- 5. Pay attention to details
- 6. Create places for people
- 7. Develop the campus as a learning laboratory
- 8. Establish a beautiful, memorable campus environment; and
- WHEREAS, the Board of Trustees recognizes that planning for the University's long-term development of the Bowling Green campus and physical environment is a valuable and critical requirement for accomplishing the University's mission and strategic plan; and
- WHEREAS, the Office of Capital Planning & Design, through collaboration with other departments, task and focus groups, and numerous campus and community constituents, have worked with professional consultants to perform critical analytical studies; and
- WHEREAS, the appropriate University offices have reviewed the proposed Bowling Green Campus Landscape and Civic Structure Master Plan and recommend its adoption;
- WHEREAS, individual landscape and civic structure projects may be incorporated with future capital projects or performed as stand-alone projects, and
- WHEREAS, future Board approval will be sought for individual capital projects as required by applicable capital project policy;
- NOW, THEREFORE BE IT RESOLVED, that the Bowling Green State University Board of Trustees approves the key design principles and authorizes the Vice President for Finance and Administration to ensure all future landscaping and civic structure projects conform to these principles.

Ms. Newlove moved and Mr. Daley seconded that the two items presented from the Financial Affairs/Facility Committee be approved.

The Board Secretary conducted a roll call vote with the following results: Voting "yes" – Mr. Daley, Mr. Keller, Mr. Levey, Ms. Montgomery, Ms. Morrison, Ms. Newlove, Mr. Primrose, and Mr. Voll. The motion was approved with eight affirmative votes.

Ms. Newlove reported that Ms. Sheri Stoll gave presentations on five informational items including an Accenture Update; the University Investment Schedule through July 31, 2014; Tentative Capital Project Board Action Items for Fiscal Year 2015; Capital Projects Status Report through August 31, 2014; and the E & G Expenditure Report through June 30, 2014.

AUDIT COMMITTEE

Ms. Daley reported that the only action item before the committee was the approval of minutes from the May 8, 2014, meeting. Discussion items on the agenda included a review of draft financial statements, presented by Plante Moran, an annual security update, presented by John Ellinger, Chief Information Officer, a summary of fraud hotline statistics, a corrective action update, and an Audit Committee training topic.

DEVELOPMENT AND INVESTMENT COMMITTEE

Ms. Keller reported that the committee had one action item to present to the Board. He moved that the agenda be amended to add the item to the meeting agenda.

Approval of Liquidation of PIMCO Total Return Fund and Re-investment in Existing Vanguard Total Bond Fund

No. 8-2015 Mr. Keller moved and Mr. Levey seconded that:

WHEREAS, the University's investment advisor, Mercer Investment Consultants, has determined that it is appropriate to make a change within the University's investment portfolio; and

WHEREAS, Mercer has recommended liquidating the PIMCO Total Return Fund; and

WHEREAS, Mercer has recommended reinvesting the funds into the University's existing Vanguard Total Bond Fund;

NOW, THEREFORE BE IT RESOLVED, that the Bowling Green State University Board of Trustees hereby approves and authorizes the University's Vice President for Finance and Administration to proceed with liquidating the PIMCO Total Return Fund and reinvesting the proceeds into the University's existing Vanguard Total Bond Fund in a timely and deliberate manner consistent with the University's Investment Policy.

The Board Secretary conducted a roll call vote with the following results: Voting "yes" – Mr. Daley, Mr. Keller, Mr. Levey, Ms. Montgomery, Ms. Morrison, Ms. Newlove, Mr. Primrose, and Mr. Voll. The motion was approved with eight affirmative votes.

Mr. Keller reported that the committee also had several discussion and information items on their agenda including a review of market performance and July 31, 2014, investment schedule, Foundation Chief Investment Officer (CIO) Consulting Services Agreement, and a development and campaign update.

GOVERNANCE COMMITTEE

On behalf of the Governance Committee, Ms. Morrison presented Mr. Bruce Nybery as a candidate for National Trustee.

National Trustee: Mr. Bruce Nyberg

No. 9-2015 Ms. Morrison moved and Mr. Daley seconded that:

WHEREAS, Mr. Bruce Nyberg graduated cum laude from Bowling Green State University in 1968 with a bachelor's degree in business administration, and earned a master's degree in business administration in 1972 from the University of Michigan; and

WHEREAS, Mr. Nyberg was employed by NBD Bancorp, Inc., now a part of J.P. Morgan Chase, from 1973 until 2001, during which he served as Senior Vice President and Division Head; and

- WHEREAS, from 2001-2007, Mr. Nyberg served as Eastern Michigan Regional President of Huntington Bank, Columbus, Ohio; and
- WHEREAS, Mr. Nyberg has served as a Director of Birmingham Bloomfield Bancshares, Inc. and Bank of Birmingham; and
- WHEREAS, Mr. Nyberg joined Flagstar Bank March 17, 2014, as interim director of Community Banking, with responsibility for Retail Banking, Commercial Banking, Warehouse Lending, Investment & Insurance Services, Government Banking, Corporate Affairs, and Marketing; and
- WHEREAS, Mr. Nyberg has served on several boards, including the Bowling Green State University Foundation Board from 2003-2009; and
- WHEREAS, as a student at BGSU, Mr. Nyberg he was a member of Student Cabinet (parliamentarian, 1967-68), Sigma Chi Fraternity, Phi Alpha Theta, history honorary, and received the Sidney Frohman Scholarship; and
- WHEREAS, Mr. Nyberg and his wife, Katherine, have two children and reside in Birmingham, Michigan.
- NOW, THEREFORE BE IT RESOLVED, that the Bowling Green State University Board of Trustees, in recognition of Mr. Bruce Nyberg's contributions to the Bowling Green State University community, appoint Mr. Nyberg to a three-year term as a National Trustee.

The Board Secretary conducted a roll call vote with the following results: Voting "yes" – Mr. Daley, Mr. Keller, Mr. Levey, Ms. Montgomery, Ms. Morrison, Ms. Newlove, Mr. Primrose, and Mr. Voll. The motion was approved with eight affirmative votes.

REPORTS - CONSTITUENT REPRESENTATIVES

BGSU Firelands, John Britton

Mr. Britton provided an update to the Board on the Allied Health and Sciences project at Firelands, including the groundbreaking on September 30, 2014. Mr. Britton praised George Mylander's service, advocacy, and contributions to Firelands. West Building was also renamed George Mylander Hall on September 30. He concluded by thanking Dr. Mazey for her donation and presence at the Firelands events.

Administrative Staff Council Representative, Dr. Emily Monago

Dr. Monago informed the Board that the Administrative Staff Council (ASC) is working to increase the commitment to student scholarships. There are eight ASC committees and they have set goals for the year. The Professional Development Committee was noted as ASC's goal is to provide webinars, podcasts, etc. to further education for administrative staff members.

Classified Staff Council Representative, Deborah Lowery

Ms. Lowery thanked the Board for the opportunity to present and introduced herself. She stated that there are 22 members of Classified Staff Council or one representative for every 30 staff members. Classified Staff Council's largest goal is the education of staff and an increase in the information flow from Council to staff.

Faculty Representative, Joel O'Dorisio

Mr. O'Dorisio reported that Faculty Senate is active, efficient, and interactive in its discussions and work this year. A goal for this year is for committees to be more efficient and tied to the University's mission. More community leaders are invited to Senate meetings and interactive breakout sessions are planned, creating a great opportunity to fully utilize talents.

Graduate Student Representative, Michael Smith

Mr. Smith informed the Board that there have been some concerns raised regarding the recent increase in graduate fees and that the GSS hopes for improved shared governance in the future. He said goals for the year include

improved communications and increased funding for internships and stipends.

Undergraduate Student Representative, Brian Kochheiser

Mr. Kochheiser provided an update to the Board on USG's goals for the upcoming year and reviewed recent accomplishments. He informed the Board of the "It's On Us" campaign to raise public awareness to help prevent campus sexual assault, as well as Falcon Care, which is a donation program to help students in need. Ms. Kochheiser noted USG's involvement in voter registration initiatives.

ANNOUNCEMENTS

Mr. Voll made a few brief announcements before the Board's adjournment. He announced that the next meeting will be held on December 5, 2014. He reminded attendees of the many homecoming activities taking place over the next two days.

Mr. Voll continued the tradition of "passing of the gavel" to give Trustees the opportunity to highlight accomplishments and efforts of programs and individuals at Bowling Green State University.
