- Showed an outstanding commitment to EGSU by their voluntary involvement in campus/community activities.
- Provided excellent customer service to the EGSU community.
- Demonstrated exemplary commitment to the core values of PGSU.

Answer this question: What has your nominee done that distinguishes her/him in the selected criteria? Be specific as to the contributions that make her/him deserving of this award. The nomination form must be completed with all pertinent information about the nominee's qualifications for the award. Nominations will be accepted from current EGSU students, faculty, classified, and administrative staff members.

Award Presentation - The award(s) will be given annually at the Spring ASC reception. The award(s) will consist of a hand-painted ceramic "Falcon" replica named **B.G. Best**. Each recipient will also have the award recognition placed in their personnel file in Human Resources and a copy will be shared with their supervisor and area vice president.

This year we have seen a revival in professional development activities for the administrative staff because of the work and dedication of a group of individuals willing to put forth the extra effort required to bring programs to fruition.

Claudia Clark, Tony Howard, Dan Parratt and Amy Prigge worked with me throughout the year to implement three programs that benefit the staff at BGSU. They willingly came to meetings every 2-3 weeks and assumed assignments to put our ideas in operation.

Amy and Dan in particular worked with the *Professional Connections* program. While this program was introduced the year before it needed to be organized and mentors needed to be recruited for the new staff members interested in the program. We currently have 8 new staff members with 14 mentors in the program. We understand that the Office of Human Resources is looking to use this program as a model for the other constituent groups on campus to adopt.

Claudia and Tony concentrated on developing and implementing the *ASC Professional Development Grants* program. This included developing the criteria, the application and award process. To date five grants totaling \$2367 have been awarded to administrative staff members.

The recent "Invest in Yourself" mini-conference was the result of the efforts of this entire group. The group determined early on that we wanted to provide professional development opportunities to as many administrative staff members as possible. The conference was a huge success as 135 BGSU staff members registered for the conference. Our target goal was 72 so one can see that we greatly exceeded our expectations. From determining topic needs, to finding facilitators, to organizing the details and utilizing campus resources this group of individuals was committed to producing a first class event and they achieved that goal.

The criteria for the B.G. Best Award has been met by these individuals as they have brought new programs to the campus community and they have done it through their voluntary involvement above and beyond their regular work assignments.

Phyllis has worked with our office numerous times to implement new programs which have had a direct benefit to the BGSU learning community. One of the more recent ideas and programs was the implementation of Schedule 25 (the automatic room scheduling package). Her creativeness and dedication to the project was invaluable to the success of Schedule 25.

- The benefit for Registration and Records was to eliminate the manual process of assigning classes into classrooms a task that required at least 6 weeks of work.
- The benefit for Departments and Faculty was to allow them to have more control as to where and what type of classroom they prefer to teach in.
- The benefit of Schedule 25 for students is the package itself. It frees up space on campus by eliminating classroom waste so students have an easier time in finding space for their meetings.
- The benefit for the University is the reports it will generate to show utilization of each classroom and each building.

You may be thinking that this is her job and that she does not deserve the recognition of the BG Best Award. However, what you don't know about Phyllis is the way she goes beyond her job description. It is not uncommon to find her in the office very early in the morning to make sure that a particular batch job has run correctly or to see that the Star System is working properly. If a problem arises she is one of the first to know about it and has diagnosed the problem before the rest of the office has even begun their day.

These days Phyllis has been reassigned to the DB2 conversion project and is working closely with Residential Life. Registration and Records surely feels the absence of her presence, but I know that due to her efforts that this project will be as successful as well.

Her skills and competency not only make me and Women's Studies look good, she inspires me to do better work.

Cooperation: Arlene works in seamless cooperation with the Director of Women's Studies, students in the program and students scheduling WS courses, the graduate T.A.s, the undergraduate coordinator, the advisory committee, and anyone else that needs her guidance or assistance, on a daily basis. She goes out of her way to help anyone who asks and is always respectful of others' needs. If she doesn't know the answer (which is rare), she finds out how to get it. Arlene never sends anyone away without having assisted them in some way. Creative imaginings: Arlene is generally the one who designs brochures, publicity, party favors (like the lovely clothespin magnet at the fall reception), envisions how an event would be best catered, and so on. Further, it is generally Arlene who comes up with the most imaginary themes for events such as Women's History Month. Yes the 1995 theme, "Out of the Mouths of Babes," was one of her creative imaginings. Her work contributes to the intellectual growth of students by serving as a central resource for anyone who is seeking to learn more about the lives of women and feminist scholarship and seeks that connection through our office or through the events we program. Examples: Arlene is fully responsible for the construction, production and distribution of the Women's Studies course list to the campus community twice a year. This list is vital for centralizing our cross-listed courses in one place so that the campus community can see at a glance what courses are available and how to register for them. The accuracy and distribution of this list twice a year is central to the visibility and viability of the Program. She creates publicity materials for events like Preview Day and President's day, she keeps current logs of all job postings, conferences, calls for papers and so on in Women's Studies for any student who desires the information—and so much more.

While many are not aware of this, the work of the Office of General Counsel is very often preventive — to keep questions from becoming problems, and problems from becoming lawsuits. Nancy's knowledgeable advice to a wide range of employees aids in avoiding or reducing exposure to legal risks and creates an awareness of the legal ramifications of proposed actions.

To say that Nancy provides first-class legal services to University clients would be incomplete without understanding the diversity of how "client" can be defined — in any given situation it could be the board of trustees, the president, provost, vice presidents, deans, or employees who, because of the nature of their duties, are named in lawsuits or administrative complaints.

The breadth of legal issues for which Nancy is responsible is enormous. In an age of increasing specialization among lawyers, in-house counsel must be consummate generalists, but conversant in many topics. I have witnessed Nancy's skill and ability to "shift gears" at a moment's notice ... day after day after day.

The office has often played a central role in policy formulation, from matters ranging to employment, student rights and compliance with federal and state regulations. The very nature of the work in the office prohibits me from going into specifics about particular topics – suffice it to say that Nancy handles so many issues that the majority of the university community likely doesn't even know an issue or problem has been raised and resolved.

I believe that Nancy is truly one of "BG's BEST."

1999 BG Best Nomination

In my sixteen years at BGSU it has been my privilege to work with many energetic, creative, caring individuals. The person who most stands out in my mind from all these is Naomi Lee. When I read about the BG Best Award, I immediately thought of Naomi. I believe Naomi exemplifies all the core values in the way she carries out her work. I would like to illustrate by giving some examples.

I have served on a number of committees and task forces with Naomi. I have observed the respect she has for her colleagues, the careful way she listens, the reflective way she responds. When she serves on a committee she does more than her share of the work. For example, the President appointed an Advising Task Force a few years ago. Subcommittees were formed and a large report needed to be put together. Naomi volunteered (to everyones' relief!) to collate all the small reports and produced a report that we could be proud of. This was not a small undertaking. She has been the same kind of committee member on the Advising Advisory group. She is never selfish with her time or talent.

Naomi's talent seems to be part natural, part the result of many years in the field and also partly that she has been very active in several national professional organizations. She has learned alot from others and has been able to develop much expertise. Whatever it is, the BGSU community has benefited from it!

Naomi is creative in her work. Last Fall she put together a cleaver "Passport" for her entering freshmen students that explains to them what they need to know as they embark on their BGSU journey. The Passport carries out the journey metaphor in an enjoyable, informative way.

Naomi's pride in how she does her job is well illustrated by the wide variety of programming she undertakes and by the amount of time she gives to assure whatever needs to be done is done. She is here early, stays late, and comes in on weekends. She has also gotten faculty and students involved in recruitment and retention efforts. For example, the last two years she has given faculty the names and phone numbers of a few new freshmen in the college and has encouraged them to call the students. She has current students write to prospective students. All this takes time and effort to lay the ground work so these efforts are played out in a positive way. If the College of Technology enrollment numbers are any indication, her efforts have been successful.

Naomi looks for ways to get students and faculty together outside of the classroom. She holds a graduation breakfast for students, parents and faculty. She has a Dean's list reception each semester, a freshmen breakfast in the Fall. She has "cider day" in the Fall and invites faculty and students to come enjoy. She provides snacks for students during finals week. (Naomi is quite a cook). She invites faculty to share the snacks with the students. She convenes freshmen to find out why they came to BGSU and what their experience has been in an attempt to improve her recruitment and retention activities.

In addition to all the regular programming and her special programming, Naomi has been very involved in a unique distance learning effort to individuals at Terra Community College. She has provided orientation for this group of students and has made many trips to Fremont during the semester after her BGSU workday was done.

I have only recounted a few of the efforts I am aware of that Naomi has done to create a caring, supportive learning community at BGSU. Her students have not been the only ones to benefit from Naomi. I feel like I have benefited immensely from working with her. Her "can-do" attitude is contagious and she has been so generous in sharing her expertise. I have been stimulated by her in ways I never had been before. Therefore, I am recommending her for the BG Best Award.



Please accept my nomination of Mr. Andy Wickiser for the 1999 B.G. Best Award. While Andy would have been a strong contender for the award any year since he joined BGSU, his exceptional service during the past year make him truly worthy of our recognition and thanks.

During the Summer of 1998, the Department of Psychology physically moved from the Psychology Building to Conklin Hall. Over 35 faculty, 10 staff, 110 doctoral students, two computer labs, and two centers/institutes from Psychology moved across campus. The move took place over a three-week period, and even our well-laid plans for who would go when were quickly swept aside by the unpredictability of such a large move. All of us were concerned about technological problems which would affect our summer research programs, grant applications, computer labs, our ability to communicate via our departmental network, videotaping of graduate student clinical supervision sessions, and much more.

Andy brought order to our chaos with a smile. Before moving, he assured us all that he would make sure our network connections were up and running the same day our offices were moved. He physically carried computers from one location to the other, disconnecting and reconnecting computers to the network on the fly, readdressing computers to new network locations, and troubleshooting wiring problems in Conklin Hall. Andy did this every day for three weeks, working late many evenings and coming in on weekends just to make sure that technology issues were not part of our troubles with the relocation. At the same time, he personally rewired a new videotaping system for our Psychological Services Center, which had to be moved over the weekend so that client treatment sessions would not be compromised by the move. I still have vivid images of Andy perched on a ladder, drilling through brick walls during the heat and humidity of August (Conklin Hall is NOT air conditioned!), working until the job was done - well past five o'clock. This part of our transition from the Psychology Building to Conklin hall went very smoothly, and many people never realized how big a job it was for Andy.

When people try and thank Andy, he is always quick to downplay his hard work or exceptional competence. From his perspective, he is just doing his job. But from my perspective as department chair, I can tell you that it is because of Andy Wickiser that our department is what it is - a place where faculty and students can reach their full potential through the exceptional service and support by people like Andy. He is one of the hardest working, most reliable, and most capable individuals with whom I've had the pleasure to work, and I am delighted to nominate him for your award. It is time that we all thank him.

Nomination for 1999 B.G. Best Award Lois Sonnenberg

Many prospective adult learners find the university an intimidating and foreboding place. The thought of entering school after being away for a length of time is often quite an anxiety provoking event. Many students change their minds after they encounter Lois Sonnenberg.

Defining customer service is a difficult task, and too often, I think, we are tempted to define it by evaluating exactly how many people we serve, or by what percent of our responses we make on time. If, instead, we define it by thinking about the impact that we have on the people we serve, then Lois Sonnenberg is a model for the university in customer service. Lois's enthusiasm for the educational process and her genuine concern for the well being of the prospective students with whom she interacts is very evident in the workshops and recruitment events that she holds all over northwest Ohio. The evaluations of the workshops she holds are routinely excellent. Comments like the following are common: "It was delightful to see someone thoroughly enjoying their job. Your enthusiasm and willingness to help everyone was very evident". Or, "Lois does an outstanding job--both in explaining and making your feel comfortable." With the population we serve (adult students), making people feel comfortable and welcome is just as important as giving them good information.

Although Lois' primary function is to recruit adult and evening students for BGSU, she offers substantially more to the prospective students she meets. When students complete one of her library workshop series or the "Crossroads: Choosing New Directions" classes, they leave not only with information about returning to school (although that <u>is</u> important), but they also take with them new-found confidence about their abilities, new hope that they might accomplish their dreams, and a sense that BGSU is a place where they might succeed.

As she has continually improved the quality of her programs, Lois has also worked tirelessly to meet and recruit many more adults in a time when institutions are competing heavily for students. In the past year she doubled the number of evening visits we make to two year institutions, she increased the number of contacts in the business community for fall 1998 by 10% over fall 1997, and she increased the total number of prospects contacted in the fall of 1998 by 24.5% over that of fall 1997. While increasing this activity level, she has also found the time to develop and administer an assessment survey to past participants in order to continue improving our office response to customer need. All this as a 20 hour/weel: part time staff employee!

Lois' commitment to doing her job well is unwavering. She is a credit to my office, the university and her community. She is a model for all of us to comulate when we interact with our customers and our colleagues. Even those prospects she interacts with who decide not to attend BGSU become good will ambassadors for the university because of the professional and caring attitude they see in Lois. Because she has had such a profound impact on the lives of so many of our adult students, and because I don't know what I would do without her, I enthusiastically nominate Lois Sonnenberg for the 1999 B.G. Best Award.

Active in both the campus and local communities, she seems to be everywhere. This year she is working with Milt Hakel to implement a Senior Year Experience Program on the BGSU campus; next month she is co-sponsoring a teleconference on the topic. She is currently chairing the first-ever "Family Campaign" for the University and almost single-handedly recruited a core group of volunteers to assist with that project. These two projects could be attributed to her "job" as director of annual giving at BGSU, but Sue gives more than required. As one of the people working with her on the campaign, I see not only her commitment to the project but also her dedication to BGSU. She wants the campaign to succeed because it will be good for the University; not because it will be good for her.

In the realm of customer service, this past year Sue chaired a committee within the University Advancement area that brought customer service training to the entire division. She organized the training sessions, secured both internal and external resource personnel for presentations and provided the division with posters and wallet-size cards to remind us of the importance of serving customers, both internal and external.

Outside her area, Sue has been a volunteer coach for Springboard since the program was piloted three years ago. She is a caring coach who brought a new dimension of connection to the three students she has coached. Sue has also volunteered annually for the admissions Presidents' Day visit program, the last two years as a bus tour guide. I have had the opportunity to observe firsthand her spirited presentations and the enthusiasm she conveyed to the visitors who were fortunate enough to ride her bus.

In the community Sue has chaired an American Cancer Society Relay for Life team the last two years. She recruits volunteers, plans fund-raising events and in general generates enthusiasm among the other team members. She is also a member of the Board of Directors of the Northwest Ohio Parkinson's Foundation and a member of the Steering Committee of the Toledo Parkinson's Support Group. At her church (St. Mark's Lutheran) she is active in the Friends and Family at College program.

Sue has been involved in more fund-raising activities at BGSU and the community than I can recall. She leads those events by example—giving of both her time and her financial resources. She is a member of the Dean's Council in the College of Arts and Sciences, which requires a minimum commitment of \$5,000.

It has been my privilege to work with Ute Patsch Lowery over the last few years. As director of the Children's Miracle Network I have witnessed the organization and success of Dance Marathon. It was during the second year that I met Ute. I was extremely impressed with Ute's ability to lead students. She, not only lead them to record breaking success, but shared her personal values. They worked together as a team. I saw students who did not know each other form a committee for action. Ute taught them tolerance, kindness, team spirit and how to give of themselves. I know that when these students return to their communities as graduates, they will take the experiences they learned from Mrs. Lowery into their own lives and communities. It is very easy to pick out the students who have been mentored by Mrs. Lowery, they are very special people just like she is. Ute Lowery is not only a credit to Bowling Green State University, but she is an inspiration to everyone who is fortunate enough to have met her. She will continue to bring success to Bowling Green State University.

Ute also recently traveled to New Jersey over spring break to assist with the first Dance Marathon at Rutgers University. JoAnn M. Arnholt, Dean of Fraternity and Sorority Affairs at Rutgers, commented on the support she offered to the students and staff at Rutgers:

Ute Lowery has been a tremendous help in our first Dance Marathon effort. Each time I called looking for suggestions or advise, she was ready and willing to help. Ute even made the trip to New Brunswick to observe the actual event and provide hands on assistance during the entire weekend. She is a true professional that understands how much good the entire Dance Marathon experience can bring to a university and its students. Bowling Green is very lucky to have this professional on its staff.

Katie Lowe, who served as a graduate student advisor to the BGSU Dance Marathon in 1996 and 1997, recently reflected upon the contributions that Ute has made to the event and her impact upon the lives of the students she has worked with. She said,

Ute's commitment to making BGSU's Dance Marathon a university wide event is remarkable. Ute has worked with the project from its inception and has worked to include Greek students, residence hall students, faculty and staff in the largest student run philanthropy in Ohio. Her devotion to making the most of the experience for each person involved is one of the things that has helped Dance Marathon grow to such a huge success. Ute Lowery has an incredible ability to help students become and do more than they think themselves capable. Her knowledge of university resources and the countless hours she puts into this event on top of her other responsibilities make her worthy of recognition as one of BG's Best.

Ute's work with Dance Marathon goes well beyond that of simply being an advisor. As Mefty indicated in her comments, Ute is a mentor to many of these students as well. Her work with Dance Marathon also transcends that of an advisor. For example, with her encouragement Ute's UNIV 100 class participated in Dance Marathon in 1996--the first class group to participate in the event at BGSU.

To me, honoring BG's BEST means that we look to those we admire and hope to model. In making the award, we signal how much they are valued and that we aspire to learn from them. It is in this context that I submit for your consideration the name of Deb Conklin, Executive Assistant to the Chair in the Department of Psychology, While she doesn't have as high a staff profile on campus as some, she is performing at an extraordinary level, day in and day out, and has been for many years. She has been a "constant" in a department that has been shaken to its core by the loss of colleagues and friends. While they now question just what can be counted on in a seemingly perverse world, they have come to count on Deb. I have worked with her and watched her perform beautifully under the most trying situations—giving solace to her colleagues, guidance to the staff, providing leadership where it was needed, just being the one everyone could lean on. For handling this exhausting role (the one that wouldn't be found on a position description or any Mercer Analysis!), she is worthy of our admiration on a human level. For performing so competently and displaying unfailing good judgment in dozens of very difficult situations like those I will mention, she is most worthy of this award on a professional level.

A little history is in order: Deb Conklin has been a critical member of the Psychology Department since 1982--first as office manager and then as executive assistant to the Chair. This department with its 83 full and part-time faculty and staff members is among the largest on campus. With its huge undergraduate program (more than 500 majore) and nationally ranked Ph.D. program, it is bigger and more complex than some of BG's colleges. Beyond that, there have been unusual circumstances in Psychology that have placed unique demands on her. In the mid- 1980's, two psychology faculty members died within days of each other just before the start of the fall term. The department was in chaos while decisions needed to be made about covering classes, making memorial arrangements, cleaning out their offices, and helping the families. Deb. was there in the center helping--coordinating the department's response, seeing the routine and not-soroutine work got accomplished. The students were served. In 1989, when Bob Conner was her chair, she worked with him through cancer treatment. Then the week before classes were to begin in August, he suffered a serious debilitating stroke! I know who kept things running while the department recovered from their loss in leadership. Deb stepped in to make sure the responsibilities assigned to the Chair were handled--classes scheduled, new students greeted, contract requests made, new faculty welcomed and equipped. She assumed the hundreds of endless duties that must be addressed and handled them with great poise even in the face of other traumatizing events, even, I suspect, when she wanted to go home and grieve herself.

Deb accepted and worked with a new chair in 1989 and then gave him over to the College in 1992 when he was asked to step in as Dean. In 1990, Psychology lost another faculty member to suicide. In 1993, she began work with a new Chair. Anyone affiliated with an academic unit will appreciate the hundreds of duties that must be accomplished and will recognize the role the assistant to the chair will carry in his/her absence or during a transition or a training period.

In 1993, the wife of the former chair/now Dean --and a <u>close friend</u> of Deb's -- died after an unexpected and brief illness. Then just last month, Doug Ullman, senior Psychology faculty member, died suddenly. Frankly, I don't think any of us can imagine the stress of handling this much loss, of being intimately connected to the families who have suffered those losses, planning endless memorial services, counseling those having difficulty, finding time to listen and then listen some more, responding appropriately day after day. Yet, this is what Deb has had to do in her administrative staff position. Since 1986, I have watched Deb perform all of her duties and these extra painful ones-- quietly, without fail, and without compromise in efficiency or accuracy.

It is for these reasons that I believe Deb Conklin is worthy of this recognition. She has demonstrated professionalism and extraordinary strength under unique circumstances. She has demonstrated what it means to be reliable and resilient, strong and focused and seemingly imperturbable in the face of great caddness. Core values displayed? I think so: she respects and loves those around her; she has shown she will work with anyone to reach the goal of serving the department and college, and she surely should take pride in a job well done!

Participants are transported to the past where they are actively involved in an exciting and meaningful learning experience. Mrs. Braatz has been instrumental in the development of a holiday theme for the fall visitations and a spring theme, even including an authentic Maypole Dance for those who participate during spring semester. The number of volunteers, many of whom are BGSU graduates, are continuously increasing, as the community becomes more involved in this exciting endeavor. This program provides a wonderful educational activity for all involved and a most positive introduction to BGSU for students.

Power of the Pen is another program that Mrs. Braatz directs which has served to draw attention to BGSU. Power of the Pen is a competitive writing program for 7th and 8th graders. For the past eight years under Mrs. Braatz's leadership, BGSU has hosted the NW Ohio Regional Tournament, which brings over 200 writers to campus for the Saturday event. Mrs. Braatz recruits judges, speakers, arranges speakers, arranges for facilities, solicits campus departments and area merchants for door prizes and in general makes certain that all involved have a positive experience. This event has proven to be a successful recruitment experience as well as an exciting learning activity.

By her warm and positive manner, Mrs. Braatz adds much to the both the quality of programs and services as well as to the level of customer service at this university. Matt Webb goes above and beyond what is "required" to be an academic adviser. Although I have known him for several years, it was only this past year that I became aware of the level of his commitment to BGSU and his students.

Last fall I team-taught with Matt a section of UNIV 100 just for arts and sciences students (all UNIV 100 instructors are VOLUNTEERS). It was in this class that I had an opportunity to observe first-hand his sincere desire to help students succeed. He brought to each class session an exemplary depth of caring. The students related to him and knew that he was one person on whom they could count to answer their questions and help them navigate the extremely difficult freshman year. He allowed the students to know him as a person as well as a professional. He advised them in class and encouraged them to schedule appointments so he could advise them outside of class, even if they were not his "assigned" advisees. He took the time to contact students whose performance in class was less than satisfactory; he planned in-class and out-of-class activities that made them feel valued.

Ironically, the students "knew" Matt before they enrolled in his class. Almost without exception they admitted to being cajoled into taking the class by their parents who had met Matt during Orientation & Registration. "Take a class from that man," the students reported their parents saying.

The level of his impact on the parents was evidenced by the fact that he received an award at the O-Reg recognition luncheon: Matt was the person most often cited by parents as being helpful during the summer O-Reg program. Those parents were sufficiently impressed by Matt to remember his name and then write it down on their evaluation forms.

A Springboard coach when the program was still in its pilot stages, Matt has also been an active member this year of the Graduation Connections Task Force commissioned by Provost Middleton. He has been a driving force behind recommendations to improve the advising process at BGSU, not only for the students of color who are the subject of task force deliberations, but for ALL students at BGSU. His ideas on that task force have been creative but grounded in common sense.

I hope these examples show Matt for what I have observed him to be: a person who shows an outstanding commitment to the University by his voluntary involvement in campus activities and one who provides outstanding customer service to the BGSU community. If there is a person at BGSU who exhibits the core values, it is Matt Webb. He was a mentor for me in the UNIV 100 class; he is a superior academic adviser who cares about students and their parents. He is a "B.G. Best."


