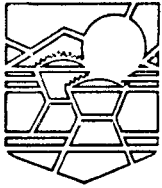

RE: Nominations

Nineteen eighty-five marks the third year in which the Michael R. Ferrari Award will be presented to a member of the Administrative Staff. The award was authorized by the Board of Trustees in 1982 to honor Dr. Ferrari who served as interim president during 1981-82. The initial recipient of the award was Suzanne Crawford, Director of Affirmative Action and the second was Zola Buford, Director of Records in the Registrar's Office.

The first step in choosing this year's recipient is the seeking of nominations. The attached Criteria Sheet outlines those factors which should be addressed in nominating individuals for the award. The nomination form is to be used, in conjunction with additional support material, for the purpose of placing names into nomination. This initial process is open to all members of the University community. The selection of the award recipient will be made by a committee of administrative staff representing the various Vice Presidential and Presidential areas. Selection will be made on the basis of the information supplied through the nomination process.

All nominations should be submitted by Friday, April 5, 1985.

The Michael R. Ferrari Award

Criteria

1. ELIGIBILITY - Any person who is a member of the Administrative Staff, i.e., non-faculty, contract employee, may be nominated. Nominee must have been an employee for at least one contract year and may not have received the award the previous year.
2. NOMINEES - must have performed exceptionally during the year and must have demonstrated more than one of the following attributes:

- use sheet for each*
- A. Innovation and initiative - a demonstration of resourcefulness in the work place including the formulation and implementation of creative new ideas. The emphasis of these ideas should be to improve the work environment, to save time and/or money and, in general, to contribute to the better overall efficiency and effectiveness of the University.
 - B. Emphasis on the human dimension - nominee needs to demonstrate a genuine sensitivity to others by showing an open, caring attitude and by being attentive to the growth and development of others.
 - C. Performance - "above and beyond" that required by the position, e.g., accepting special projects, additional responsibilities such as committee work, giving non-compensable time to effectively complete an assignment, service in professional organizations, or recognition brought to the University through the receipt of grants or through publications.
 - D. Relationship with University community - The nominee must effectively interact with faculty, staff or students in providing services that promote growth and harmony in their respective departments, areas, etc., as well as the campus. (This would not mandate service on University groups, committees, boards, etc.)

NOTE: The prominence of the University position held by the nominee should not be considered in the selection process.

Dear Joyce Kepke:

I have known Patrick Fitzgerald since he started working at WBGU-TV, way back in the early 1970's. He came to our station as a producer/director and was directly under my supervision. Fitz was an excellent producer/director...one of the best the station has had. He was not only an imaginative and industrious worker; he was also a pleasure to work with. His ability to work with people, maintain a sense of calm and perseverance under the worst of circumstances, and his creative talents were evident from the very beginning of his employment at WBGU-TV.

When the position of Director of Instructional Television (or closed circuit television) opened up at our station, Fitz submitted his application for the position upon the encouragement of myself and other staff members.

He has been the director of the closed circuit operation, now called Learning Services, since 1973. He is one of the most unselfish, hard working, dedicated, and easy to work with persons I have ever known. He has a rare mixture of talent, cooperativeness, imagination, and the leadership abilities that infect and encourage all those that have the opportunity to work with him. WBGU-TV and the University are fortunate to have him on the staff.

Fitz is known and respected inside and outside the University community. He is as comfortable working with students as he is with staff or faculty. He is WBGU-TV's main liason between the services of the station and the campus community and, as Mike Marsden points out in his letter of support for Fitz's nomination, is primarily responsible for the harmonious relationship between the station and the campus.

I encourage the screening committee to look with favor upon Patrick Fitzgerald's candidacy for the Michael P. Ferrari Award.

As Director of Learning Services at the WBGU-Television Center, Patrick Fitzgerald has established and operates six closed circuit instructional channels for academic buildings on campus; a library "study carrel" system (initially four carrels, expanded this year to eight study carrels); produced between 20-30 individual programs or series each year for campus use; assisted in the development, design, and proposed programming for an ITFC (Instructional Television Fixed Service) system for the Firelands College Campus in Huron, Ohio; assisted professors in the development of locally produced programs for use in their classrooms; and aided various academic departments in the purchase of instructional programs to supplement and enhance their instructional program.

Patrick Fitzgerald has taught part-time in the Radio-Television-Film area courses in television production, history and criticism, and history of instructional television. He has been a consultant to students, faculty, and staff in the development and dissemination of television programs, purchase of equipment, and the preparation of proposals for television production and equipment grants.

A) INNOVATION AND INITIATIVE

Since taking over the closed circuit operation of the WBGU-Television Center in 1973, Pat Fitzgerald has demonstrated his patience, resourcefulness, and vision as a leader in instructional television service to the BGSU campus. The closed circuit operation is now called the Learning Services Department of WBGU-TV. In addition to providing six channels of closed circuit instructional television programs to over 100 receiving locations on the BGSU campus, one additional channel (channel 7) provides the WBGU-TV program schedule and other programs of special interest to the campus to all residence hall lounges and advisors' rooms on campus. The Learning Services Library contains approximately 1100 programs available for use in classroom teaching.

Pat Fitzgerald was responsible for the design and implementation of a library study carrel system operated as a resource service for academic departments in cooperation with the BGSU Library. Initially there were four study carrels; four more were added this year to help accommodate the demand for this service.

I have attached an annual report for the 1983-84 academic year for Patrick Fitzgerald's department. A look at the individual findings of this report are impressive, and I will relate just a few items to highlight the report:

His most recent work with system expansion is his work on the ITFS (Instructional Television Fixed Service) for the Firelands College Campus in Huron. Fitz was one of the three people charged with the design, implementation, and use of the ITFS system. Fitz was instrumental in working out the optimum usage of such a system. He also prepared a slide show for purpose of raising funds for the building of the ITFS system. After nearly three years of behind-the-scenes work on this project, the ITFS system is expected to begin operation the beginning of April.

Another major system development project was the implementation of computer assistance in the Learning Services Department. The addition of a computer to assist in the Learning Services Department was no easy task. Creating a program and applying the technology took over a year of frustration and patience. The work to intergrate the computer into the operation took place on top of the normal day-to-day routine of faculty requests, playbacks, productions, and record keeping. In addition, Fitz was taking computer classes to help himself better understand the new technology.

Fitz worked with the University Computer Services Department to implement a program that:

- 1) Makes an inventory record of all television receivers and their placement on campus.
- 2) Records the number of requests for playbacks by faculty.
- 3) Records the number of requests by the library study carrel users.
- 4) Records the number of students viewing the playbacks.
- 5) Records the number of departments utilizing the closed circuit services.
- 6) Records the frequency of usages of a particular program, department, and faculty member.
- 7) Records the rooms used for viewing the playbacks.
- 8) Assigns channel and video tape machine for playbacks.
- 9) Prints a daily log of events for the Learning Services Department.

The Learning Services Department has recently added a character-generated message service that announces various campus and related University activities. The message service is presented on the closed circuit channels during the time between scheduled playbacks of instructional programs.

B) EMPHASIS ON THE HUMAN DIMENSION

Pat Fitzgerald's door is always open to students, staff, and faculty. Fitz has been a mentor to many students at WBGU-TV. He has given them an opportunity to develop and refine their skills and talents as broadcasters in writing, directing, and producing television programs for both closed circuit and broadcast. He has taken the time to work one-on-one with these students who in the last few years include: Debbie Ondo, currently a producer/director at Channel 11 in Toledo; Danelle Ochendowski, currently a director at Channel 24 in Toledo; Cathy Seem Ruggerio, currently an operating engineer at Channel 13 in Toledo; Linda Goldsmith, past production manager at Channel 13; Dave Goldsmith, currently director of closed circuit television at St. Charles Hospital in Toledo; and Tony Berenotto, currently a videographer at Channel 24.

In addition to his work with students working at WBGU-TV, Fitz has also been involved on a more personal level with students needing a friend to confide in or speak with through the Faculty Student Dialogue program. The Faculty Student Dialogue program is a cooperative service of Bowling Green State University and St. Thomas Moore University Chapel.

Susan Arpad in her letter of support for Pat Fitzgerald's nomination for the Ferrari Award (letter attached) provides additional testimony to Fitz's genuine sensitivity to others and his work towards nourishing the self-esteem and self-awareness of the Women's Studies program and women students.

Ramona Cormier testifies in her letter (attached) to Fitz's work and encouragement in the use of his services for the non-traditional student and all faculty in general for the implementation of this mode of instruction.

Michael Marsden in his letter of support (attached) identifies Fitz as a facilitator interested in helping people develop the instructional possibilities of WBGU-TV. Fitz is cooperative, imaginative, and responsible for the harmonious cooperation which exists between his instructional television services and various academic units on campus.

C) PERFORMANCE ABOVE AND BEYOND THE CALL OF DUTY

Pat Fitzgerald has been a member of the Ohio Humanities Council for the past four years and is currently chair-elect of the organization. His responsibilities as chair will take effect this fall. As a member of the OHC, Fitz has been a member of the reviewing committee that decides on grants for television projects dealing with the humanities. As a result of his membership on this committee, he has been an invaluable aid to faculty and staff interested in applying for grants. His insights on what the OHC generally accepts and what they simply will not take into consideration has transformed the position of many a grant writer from frustration to fruitful. Although Fitz cannot vote on proposals submitted by the University, WBGU-TV and the University have been extremely successful in receiving grants from the OHC.

Fitz has a genuine interest in the use of television as a communicator of knowledge and ideas. This interest in the use of television as an instructional tool is evidenced by his work with Ramona Cormier, Dean of Continuing Education; William McGraw, new Dean of the Firelands College Campus; his membership on the Non-Traditional Student Advisory Committee and with academic departments trying to intergrate television courses of instruction into a degree program for the non-traditional student.

He voices this interest as a member of the Ohio Post Secondary Telecommunications Council and the University's Telecommunication Advisory Committee.

In addition, Fitz serves on the executive committee of the Ecumenical Communications Commission, last year serving as its president. He is also a member of the Vice Presidential Area Grievance Committee, BGSU.

Membership on such a wide variety of committees provides a good indication on the value others place in Pat Fitzgerald's leadership and decision-making ability.

D) RELATIONSHIP WITH UNIVERSITY COMMUNITY

The attached letters of support for Pat Fitzgerald's nomination to the Ferrari Award, I suspect, speak more loudly than I could in reference to his relationship with the University community. The list of committees on which Fitz is a member will also indicate the involvement and dedication that Pat Fitzgerald has to his position at WBGU-TV, the University, and the Bowling Green community.

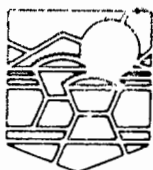



Ferrari award given

Dedication, resourcefulness earn recognition

This year the University presented Patrick Fitzgerald, director of learning services at WBGU-TV, with the Michael R. Ferrari award in recognition of his sensitivity, resourcefulness, and commitment.

The award, which was created in honor of Michael Ferrari, interim president of the University in 1981-82, was presented to Fitzgerald at a meeting of the administrative staff on Aug. 23. Fitzgerald's name will be engraved on a plaque in the contract personnel services office, and he will receive a work of art which has not been selected yet.

Karen Mason, assistant director of television-learning services, describes Fitzgerald as efficient, sensitive and patient. "I can't say enough good things about Pat Fitzgerald. People just love him," she said.

Joyce Kepke, chair of the Ferrari Award Committee, said there was not just one thing that made Fitzgerald exceptional, but that he had performed well in all areas of criteria.

Mason said Fitzgerald deserves the award because he is very good at what he does and is quick to respond to problems. She added that working with him is very enjoyable and that he relieves some of the tensions of the job. "People just know they can come to him for help," she said.

FITZGERALD SAID the award was based partly on the many expansions in his department in the past year. This past year he worked to increase students' access to the tape library and to expand Instructional Television Fixed Services to the Firelands campus. New Firelands can offer courses to students in their homes, he said.

Fitzgerald's responsibilities include the closed circuit system and the ITFS. He also produces instructional programs for various departments on campus.

"One of the exciting things about this job is that everything is different every week. It's intellectually stimulating because we work with different departments each year to create programs," Fitzgerald said.

Fitzgerald received a bachelor's degree in philosophy from the University of Dayton and a master's degree in television broadcasting from Brooklyn College in New York. He came to Bowling Green in 1973, working in production and direction at WBGU. He has been in his present position for 11 years.

Criteria for the Ferrari award include resourcefulness, sensitivity, a good relationship with the University community, and performance beyond that required.

COMMENTS FROM KEPKE!

We agreed as a committee that everyone who was nominated should be told they were nominated, both because it is an honor to be nominated and also to allow them a chance to withdraw from nomination if they did not want to be considered.

After the entire process was completed we discussed the procedures. We agreed that the amount of material submitted was just too varied. After discussing several alternatives we decided to recommend to the 1986 committee that they alter the nomination form. We suggest putting each of the attributes on a separate sheet (even though that produces a lot more paper), in the hopes that the nominators will understand that they should offer more information than just "he is a nice guy"! We also debated about accepting all the extra information that some people submitted but did not make a decision.

We also discussed whether we should ask the two other references for information or a letter. We decided that the committee should only ask for letters from them if the decision was close and the committee needed to have more information.

We also discussed whether the voting should be absolute - whoever received the most points was the award recipient. The committee was split but the majority agreed that if there were several nominees who were very close that they would like to discuss the nominees and then vote again. I feel personally that we should do this since not everyone knows all the people nominated. However, we did agree that we should make our decisions on the material that was submitted. If the nominator did not make a good case we felt we should not add to what was submitted.

A note to the committee chair - ask the executive committee to suggest names for the committee of people who have been on campus for at least two years and preferably five years. We had a few people who were new to campus. Not only did they not know very many people but they also were not familiar enough with the campus to understand the significance of what they were reading. They felt at a loss and were frustrated.
