#### 1988 Dates To Do

Ferrari Award Standing Committee members named by the Administrative Staff Council Executive Committee. The Standing committee is responsible for reviewing the procedures to be followed in selecting the recipient and for selecting the other members of the Ferrari Award Committee.

- 11/5/87 Memo from the chair to the Ferrari Award Standing Committee scheduling the first meeting (see memo in file)
- 12/1/57 Meeting of the Ferrari Award Standing Committee. The committee reviewed the 1937 award process and guidelines with the past chair, selected the additional members and reviewed the schedule for the 1938 selection process. Items discussed relative to guidelines were:
  - 1. the award is not viewed as a "retirement" award; it is given to an individual who best meets the criteria.
  - 2. the committee is not responsible for soliciting nominees; this is the responsibility of every administrative staff person.
  - 3. committee members cannot nominate a candidate.
  - 4. committee members who are nominated have the choice of accepting that nomination and removing himself/herself from the committee or of declining the nomination and remaining on the committee.
  - 5. at the selection meeting, committee members were free to discuss any nominee; the issue was whether the committee should consider only the materials submitted or allow a committee member to discuss a candidate based on his/her personal knowledge of that candiate.
  - 6. individuals nominated in 1987, but not selected as the recipient, were eligible for renomination in 1988. Renomination consisted of the chair contacting the nominator and securing permission to include the nominee in the 1988 pool of nominees. The nominator did not have to resubmit the materials but additional information could be added if desired.
  - 7. the award should go to the individual who goes "above and beyond" what is required of his/her job; it does not go to an individual who is doing a great job at what he/she was hired to do.
  - 3. there was no limit placed on the amount of material submitted on behalf of any candidate.
  - 9. committee members read all candidate materials and select their top five; this information is complied by the chair to identify the overall top five; the recipient is determined, after discussion, by majority vote of the committee (the choice was not difficult in 1988 because the recipient was the first choice of most members). Selection of additional members of the Award Committee proceeded as

follows:

- 1. each member of the standing committee had a list of all administrative staff members; the list was provided by the Administrative Staff Council Executive Committee.
- 2. two members from each vice presidential and the presidential area

- serve on the award committee.
- 3. members of the standing committee were each counted as one representive of their respective areas.
- 4. additional members were nominated by the standing committee and were voted on by the standing committee.
- 12/2/87 Memo from the chair was sent to the additional members selected by the standing committee asking them to serve on the award committee; all agreed to do so.
- 1/9/88 Memo from the chair sent to members of the award committee scheduling the first meeting of the entire committee; the agenda for this meeting is included in the files. Mailed with the memo were the following materials prepared/updated by the chair:
  - 1. copy of the selection criteria
  - 2. copy of the nomination form
  - 3. agenda for the meeting
  - 4. list of members of the award committee.

- 2/17/83 Chair has additional copies of the criteria sheet and nominating form printed; printing costs are charged to the ASC budget.
- 2/13/88 By telephone, the chair contacts the following:

    the administrative staff and to secure permission to place nominee
    files in that office for review by the award committee.
  - 2. Norma Stickler to request mailing labels for deans and department chairs who receive award information.
  - faculty senate and bookstore for permission to place copies of the application information in these areas.
- 2/29/88 After receiving the printed copies of the selection criteria and the nominating form, the chair:
  - prepares and sends to Fublic Pelations a memo requesting that information re: the award be placed in the Monitor and Green Sheet (see memo in files)
  - prepares and sends to the PG News a memo requesting that an ad announcing the opening of noninations for the award (see memo in files)
  - 2. prepares for use by the Administrative Staff Personnel Office a memo announcing the opening of nominations for the award; enough copies of this memo, criteria sheets, nominating forms and envelopes are provided to the Administrative Staff Personnel Office for each member of the administrative staff; that office mails these materials (see memo in file).
  - 4. provides about 25 sets of the criteria sheets and nominating forms to the faculty senate office and bookstore.

Nineteen eighty-eight marks the sixth year in which the Michael R. Ferrari Award will be presented to a member of the Administrative Staff. The award was authorized by the Board of Trustees in 1982 to honor Dr. Ferrari who served as interim president during 1981-82. The initial recipient of the award was Suzanne Crawford from Continuing Education, the second, Zola Buford, from the Registrar's Office, the third, Patrick Fitzgerald, of WEGU-TV, and the fourth, Gregory DeCrane, Student Activities and Orientation. Last year's recipient was George Howick, Management Center.

The first step in choosing this year's recipient is the seeking of nominations. The attached criteria sheet outlines those factors which should be addressed in nominating individuals for the award. The nomination form is to be used, in conjunction with additional support material, for the purpose of placing names into nomination. The nominee must be a member of the University's Administrative Staff. Nominations may be made by members of the Administrative Staff, Faculty, Classified Staff or the student body. The selection of the award recipient will be made by a committee of administrative staff representing each of the Vice Presidential and Presidential areas. Selection will be made on the basis of the information supplied through the nomination process. Additional information and support over and above that listed in the Criteria Sheet are welcome.

A nomination form and criteria form are enclosed. Additional forms are available in the Administrative Staff Personnel Office, Faculty Senate Office, University Union Lobby, and the University Bookstore.

All nominations should be submitted to Bob Arrowsmith, 305 Student Services Building no later than April 15, 1988.

#### THE MICHAEL R. FERRARI AWARD

#### Criteria

- ELIGIBILITY Any person who is a member of the Administrative Staff, i.e. non-faculty contract employee, may be nominated. Nominee must have been an employee for at least one contract year and may not have received the award the previous year.
- 2. NOMINEES Must have exhibited exceptional performances and must have demonstrated an emphasis on the human dimension. This means that the nominee exhibits a genuine sensitivity to others by showing an open, caring attitude and is attentive to the growth and development of the University. In addition, the nominee must demonstrate at least one of the following attributes:
  - A. <u>Innovation and initiative</u> a demonstration of resourcefulness in the work place, including the formulation and implementation of creative new ideas. The emphasis of these ideas should be to improve the work environment, to save time and/or money and, in general, to contribute to the better overall efficiency and effectiveness of the University.
  - B. <u>Performance</u> "above and beyond" that required by the position, e.g., accepting special projects, additional responsibilities such as committee work, giving non-compensable time to effectively complete an assignment, service in professional organizations, or recognition brought to the University through the receipt of grants or through publications.
  - C. Relationship with University Community The nominee must effectively interact with faculty, staff or students in providing services that promote growth and harmony in their respective departments, areas, etc., as well as the campus. (This would not mandate service on University groups, committees, boards, etc.)

NOTE: The prominence of the University position held by the nominee should not be considered in the selection process.



It is with great pleasure I submit the name of Richard Conrad for the 1988 Ferrari Award. For the past 11 years, I have worked with Dick and have the highest regard for him in areas directly related to the Ferrari Award criteria.

In his primary position as Director of University Computer Services and Telecommunication Services, Dick's ability to guide the efforts of a very large, central department is proven. In the case of Telecommunication Services, he took over an area plagued by administrative and functional problems which were, in my opinion, an embarrassment to the University. Dick personally became involved in all details of the office to the point where he could knowledgeably institute many technical, managerial, financial, and operational improvements.

In Computer Services, Dick has led the area through tremendous changes and improvements in our ability to serve both administrative and academic computing users. The accomplishments which have taken us from a relatively obsolete installation to a modern, state-of-the-art operation are extremely impressive. Perhaps even more impressive is the way in which Dick accomplished these goals.

Change has a way of making people feel uncomfortable and resistant, yet in Telecommunication Services and Computer Services, change is a way of life. However, since these two areas affect so many others on campus, change must be instituted in a participative, planned fashion. Through the new Telecommunication Services Advisory Committee, the University Computing Council, the

Administrative Computing Council, the Task Force on Computing, the Academic Computer Users' Advisory Committee, and other related groups, Dick has set an example by listening to what people have to say and involving them throughout the process.

Both areas are a testimony to Dick's many innovative ideas. Many of the innovations are of a technical nature, which are not easily explained in this letter. Others, ranging from our approach to microcomputer sales and computer lab planning to the 911 emergency telephone system, are innovations which other universities in the state are still studying. One of these was recognized by the National Association of College and University Business Officers, (NACUBO), for which Dick and BGSU received special recognition. A second one has been submitted to the NACUBO "Cost Reduction Incentive Award Program" (see attachment).

Dick also continues to teach in the evening for Computer Science as a way of keeping in touch with students and their concerns. In spite of his heetic schedule, he always makes time for student questions and problems throughout the day. This aspect of his personality, the need to be responsive and open to students, has been demonstrated on numerous occasions in his primary capacity as well. Whether talking with student groups or soliciting student feedback on telephone or computer issues through surveys, his concern for the impact of technology on people is constant. In addition, he has been involved with numerous graduate students as the chair or a member of their thesis committees.

Perhaps the greatest testimony to Dick's character and reputation as a University representative involves his community service work. As a member of several United Way regional committees (see attachment), his perspective has been relied upon to evaluate recipients and distribute United Way funds. As a member of the Wood County Probate Court Citizens' Review Committee, Dick's human insights are relied upon in dealing with problematic domestic and juvenile cases. At BGSU, Dick has been involved in Administrative Staff Council(ASC), ASC Executive Committee, the Computing Task Force, as well as many computer, telecommunications and other committees.

In conclusion, I enthusiastically submit the name of Richard L. Conrad for consideration for the Michael Ferrari award. His duties in administration, education, University and community service are all totally consistent with the evaluation criteria. If you have any further questions, please feel free to contact me.

# Supporting Criteria for Richard L. Conrad's Nomination

## A. Innovation and Initiative

The initiative Dick Conrad has taken to develop many innovations in the last few years has contributed greatly to the betterment of the University and saved BGSU hundreds of thousand of dollars. University Computer Services is one of the leading computer services department in the state, if not the country. This is continuously demonstrated by the number of requests we receive from other universities and companies to visit our site, or to obtain copies of our programs and other materials. The number of articles published about the new ideas Dick Conrad has developed, as well as the awards and honors received are all indicative of the excellence demonstrated by Computer Services. The following are some examples of this initiative and the resulting innovative ideas:

- He was instrumental in the design and installation of the BGSU "enhanced" 911 emergency telephone system. This life saving system, which typically costs hundreds of thousands of dollars and takes years to install, was installed in four weeks and at no cost to the University.
- He facilitated the opening of the first microcomputer laboratory at BGSU (which was also one of the first microcomputer laboratories in the country) and managing the growing use of microcomputers. We now have over 15 laboratories and hundreds of microcomputers. Microcomputers are now readily and easily accessible to all students, faculty and staff.
- In 1982, his idea of establishing a microcomputer laboratory in West Hall was the winner of the National Association of College and University Business Officers (NACUBO) Cost Reduction Incentive Awards Program "Honorable Mention". He has submitted the "enhanced" 911 system as the University's 1988 entry to this program.
- He was responsible for establishing a rental pool of microcomputer systems. These microcomputers are available at a very economical price to all students, faculty and staff.

- He was instrumental in the replacement of the DEC 2060 computing system with a new DEC VAX 8530. He is also credited with acquiring a DEC VAX 11/780, VAX 11/785, as well as the IBM 4341 which is dedicated to interactive statistics. These systems significantly enhance the computing resources available to our students and researchers.
- He helped facilitate access to the Ohio Supercomputer in Columbus for all University researchers at no cost.
- He was responsible for the acquisition of IMAGINE. IMAGINE is a very innovative tool which enables administrative CICS users to easily retrieve data and print reports. Prior to the implementation of IMAGINE, special programs needed to be written to provide users with this information. This tool has saved thousands of hours of precious programmer time and enabled users to almost immediately generate needed reports. During its first year of operation, over 3,000 reports have been generated using IMAGINE.
- In the past 10 years, he has been responsible for obtaining grants, awards, etc., totaling over \$500,000. During the summer of 1986, he successfully negotiated a discount of over \$200,000 on the purchase of the new DEC VAX 8530 computer system. These grants and concessions have been key elements in providing our faculty, staff and students with fine, state-of-the-art computing facilities.

## B. Performance

Dick's tireless devotion to University Computer Services, Telecommunication Services and the University is greatly responsible for the many successes which we have experienced. He is very astute in spotting problems and is always willing to do whatever is necessary to get the job done right. The following is a small list of the various services that he has performed in his efforts to bring improvements to the University:

- Dick has been a long term member of Administrative Staff Council and the Administrative Staff
  Council Executive Committee. He has been active on many Administrative Staff Council committees and has been the Administrative Staff Council representative on other University standing
  committees.
- Last year, he chaired the committee which selected the new Director of Administrative Staff Personnel.
- Last year, he was a member of one of the committees which interviewed and advised the selection committee on the new Vice President for Planning and Budgeting.
- He is participating on a committee of Library and Computer Services' personnel who will be selecting a new on-line computerized Library system.
- As a member of the Ohio Higher Education Computing Council (OHECC), he has chaired three meetings and for the third time, will be hosting the spring OHECC meeting.
- For the seventh consecutive year, Dick has collected, compiled and presented the OHECC salary survey.
- He was the University's representative to the Board of Regents committee on "merging technologies." This committee's report was primarily responsible for the allocation of approximately \$100,000,000 to the state universities over a six year period for upgrading computing and instructional equipment.
- He is a member of the Association of Systems Management and the Association of Computing Machinery professional data processing organizations.
- He is starting his fourth year as a member of the PC WEEK corporate advisory panel.
- He requested the University's attorney check with the Internal Revenue Service concerning the status of students paying excise tax on their long-distance telephone calls. The favorable ruling received from the IRS means that BGSU students do not have to pay the 3% excise tax on long-distance telephone calls. This ruling will save BGSU students over \$38,000 this year and every year hereafter. It also resulted in a \$45,000 refund from the IRS of all taxes paid since August

- He was instrumental in turning around the Telecommunication Services area. During the first year the System 85 was installed (1985-86), they lost approximately \$600,000. He took over management on July 1, 1986. During that first year (1986-87), the loss was reduced to approximately \$200,000. It appears that 1987-88 income will exceed expenses by \$100,000.
- He was a member of the Planning and Budgeting Committee which redesigned the Annual Evaluation form that is used by all contract employees in the Planning and Budgeting area.

# C. Relationship with University Community

Dick's job requires that he work with people from every level of the University. This includes the student in the laboratory, the faculty in the classroom, the President and the Board of Trustees. I feel that the success he and the University have enjoyed is a reflection of his skills as a manager and the fine working relationship he enjoys with his staff, University administration and users. Through his involvement in community projects, he has brought considerable recognition to the University. The following are several of Dick's University and community projects:

- He is currently the chair of the Computer Science thesis committee for Prasad Motupalli. Dick has chaired or been a member of numerous other Computer Science thesis committees.
- In addition to presenting papers at OHECC conferences, he was recently one of three presenters at an all day Association of Computing Machinery (ACM) conference in Ann Arbor on "Human Relations in Data Processing Management."
- He requested that Faculty Senate establish a standing committee for advisory on matters related to Telecommunication Services' budgets and policies. The Telecommunication Services' Advisory Committee, comprised of faculty, staff and students, was formed last fall and was extremely busy during their first year of operation.
- He is a firm believer in having faculty, staff and student input into the management decision process. In addition to the Telecommunication Services' Advisory Committee, Dick received advice from University Computing Council (which is in the process of updating the Bowling

Green State University five-year computing plan), Academic Computer Users' Advisory Committee and Administrative Computing Council.

- Dick is credited for the establishment of the Rachel Thurman Scholarship Fund. Rachel Thurman was a telephone operator who died last summer. He was also instrumental in the establishment of the Lynn Orwick Scholarship Fund. Lynn Orwick was a Computer Services' manager who died a year ago. The Rachel Thurman Scholarship fund was just started last fall and has already collected over \$200. The Lynn Orwick Scholarship fund has collected over \$3,000 and has already awarded three scholarships totaling \$2,000.
- He has taught a course for the Computer Science department almost every term since January 1970. This helps him in performing his regular duties as Director of University Computer Services. Teaching allows Dick to see first-hand what kind of computer services are provided to the instructor in the classroom and the students.
- He is starting his third year as a member of the United Way Allocation Panel for Children Services and will be the 1988 Vice Chair of the panel. This panel is responsible for the allocation of United Way funds to all agencies which provide children services in a five-county area.
- He is starting his first year as a member of the United Way Allocation and Agency Relations Committee. This is the committee which reviews the decisions of the six United Way allocation panels, establishes the criteria for the allocation of funds and promotes good relations with the agencies.
- He is starting his second year as a member of the United Way task force for St. Anthony's Villa. This task force assists St. Anthony's Villa in their reporting to United Way.
- For the last two years, he has been a member of the United Way allocation "Program evaluation And Review" (PAR) subcommittee for the Children's Resource Center in Bowling Green.
- He is starting his second year as a member of the Wood County Probate Court Citizens' Review Committee. This committee is comprised of seven Wood County citizens appointed by Judge Pollex. The purpose of the committee is to review and make recommendations for all juvenile cases from Wood County Human Services which are going before the Judge.

- He is an active member of the Tontogany American Legion. This is his 21st year, (17th year as chair), as a member of their Buckeye Boys State selection committee for Otsego High School. This committee selects six delegates and six alternates to Buckeye Boys State from Otsego High School. These delegates are sponsored by the Grand Rapids, Weston and Tontogany American Legion Posts. The process involves three nights with the candidates. The first night is an orientation session with the candidates and their parents; interviews are conducted on the second night; the third night is an informal atmosphere where a light lunch is served and games are played. This is also his 21st year, (17th year as chair), as a member of the Tontogany American Legion children's Christmas party committee.
- He is a past member of the Fourth Area Professional Standards and Review Data Committee. This committee was responsible for reviewing the Medicare/Medicaid records for abnormalities related to length of stay in northwestern Ohio hospitals. Reports of average length of stay by diagnosis are sent to the federal government.
- He has participated as a resource person in the Wood County Human Services' training sessions for prospective adoptive parents and foster care parents. He and his wife Joan have adopted two sons and have had four foster children for extended periods of time. His oldest son is currently a senior at Bowling Green State University, and he has a daughter who is a sophomore at the University of Michigan.
- Dick is an active church member. Some of his contributions to the congregation have included: painting the entire inside and the wooden exterior of the church, designing and building the large oak cross that hangs outside the church, and serving as a team leader for the "all member canvas" for pledges last fall. Dick has also participated in many smaller projects for the church.

This letter is being sent to support the nomination of Richard Conrad, Director of University Computing Services, for the 1938 Michael R. Ferrari Award.

Richard Conrad is a very knowledgeable, exceptionally well-organized, and highly motivated individual who has contributed much to the development of computing resources at Bowling Green State University. These accomplishments (as listed in Pich Cera's nomination letter) demonstrate very vividly the impact he has had in the last 10 years in his current position. These accomplishments can be summarized into two areas:

- 1) Computing resources at EGSU Dick Conrad's unselfish and innovative leadership has moved the University significantly closer in the computing resources needed to enter the 21st Century. He has successfully "navigated" EGSU through many mainframe and total system changes (both academic and administrative); made computer literacy a real possibility by increased number of computer labs with trained staff; has helped administrative areas increase productivity and effectiveness an example is the number of Eursar CICS transactions (1,700,000 in 85/36 to 4,700,000 in 86/37 and increasing); "nudged us" along by providing staffing to train users in what sometimes was perceived as impossible hurdles.
- 2) Telecommunications at last count, under his leadership, this particular area will move from an entremely difficult first year, at best, to a fairly smooth and more manageable level by mid-to-late summer 1933. He will have seen a growth in subscribers from 2,000 when he assumed responsibility to 8,000 subscribers in Fall 1938. In addition, he has used the new telecommunications system to implement a very low cost 911 emergency system. He also pursued the elimination of billing and collecting of federal encise tax charges to students. This latter change will save hundreds of thousands of dollars for student users.

As you can see, Dick Conrad has made significant contributions to Eowling Green State University. Just managing Computer Services alone is a task unto its own. However, two years ago, he also accepted the added responsibility for Telecommunications - an area that had just installed a new telephone switching system. His low-keyed approach and persistence in including all the "parties involved" insures the running and survivability of an important facet of the campus community. I have found Dick to be extremely tactful and sensitive to all the people around him. He takes the time to listen and is able to quickly understand what information is being provided to him. In fact, this people involvement, in my opinion, is a major reason why the areas of Computing Resources and Telecommunications continue to grow and progress under his leadership.

At the same time, Dick has continued to participate in other activities: chairing selection committees; recently hosting a state-wide conference of his computer peers; active participation in Administrative Staff Council; plus serving on a number of other committees including those in the community. Dick is willing to help even when he is extremely busy and would hardly seem to have the time.

In summary, I think Lowling Green State University is fortunate to have Richard Conrad as a member of its staff. He is a person who, in my opinion, has already made his mark. Therefore, it is with great pleasure that I very strongly support his nomination for the 1988 Michael R. Ferrari Award and for all that it stands.


