At the request of the Board of Trustees in 1982, the Administrative Staff Council was asked to create an award to recognize the service and contributions of Dr. Michael R. Ferrari. This award was established in 1983 and has been awarded each year since to the administrative staff member who has given selflessly to the betterment of the University. The award consists of a small plaque and a \$400 certificate to be used for the purchase of an original piece of art from the B.G.S.U. School of Art. Since last August, a permanent display has also been built in the hallway on the first floor of the University Union.

Since it's creation, the Ferrari Award has been funded through the operations budget of the Administrative Staff Council (ASC). While their funding was appropriate in the early years when ASC was a fledgling organization, current demands on the minimal operating funds of ASC have necessitated a ^{new} ~~change~~ ~~of~~ funding source~~s~~. In January of 1991, Administrative Staff Council approved the establishment of the Ferrari Endowment through the University foundation. The initial campaign netted \$2,523 ^{primarily} from past officers, award recipients and acquaintances of Dr. Ferrari. This amount represents 33% of the goal of \$7,500, which would allow for the continual funding of the Ferrari Award through interest generated by the ^{corpus} ~~corpus~~.

The next phase of the effort to endow the award is to solicit contributions from employees and those people who knew Mick when he was here. Dr. Phil ^{V.P. R} Mason, ~~from the~~ University Relations Office recommended that you be included among those contacted at this time. We also have received an indication from Dr. Ferrari of his desire to participate. In addition, we will be reapplying for support from the University Foundation.

I am hopeful that you will consider a donation in the \$100-¹⁵⁰⁰~~500~~ range to the Michael R. Ferrari Endowment which will allow the continuation of a prestigious award which honors both Dr. Ferrari and the contributions of outstanding administrative staff.

Thurairatnam wins Ferrari Award for his efforts with off-campus programs, international students

Dr. Dante Thurairatnam, associate dean and director of off-campus programs in the Office of Continuing Education and Summer Programs, is this year's recipient of the Michael R. Ferrari Award.

Thurairatnam received the award at the Aug. 26 opening day reception for administrative staff.

"To be recognized by peers and colleagues is something that is very precious to me. Thank you," Thurairatnam said after receiving the award. Jane Schimpf, last year's Ferrari winner, presented the award.

Administrative Staff Council Chair Josh Kaplan said three runners up for the award were Rich Zera, computer services; Ron Zwiernick, Student Recreation Center; and Jill Carr, housing director.

Created in 1982 by the University Board of Trustees to honor a University administrator who shows a caring attitude in working with faculty, staff and students and who makes outstanding contributions to the University community, the Ferrari Award honors Dr. Michael Ferrari, a longtime Bowling Green administrator who was interim president of the University in 1981-1982. Ferrari is currently president of Drake University in Des Moines, Iowa.

Thurairatnam was a student at the University from 1969-1970, returning to BGSU for a doctoral degree in 1974. He joined the continuing education staff in 1978 as director of off-campus programs and assistant to the vice provost. In 1982 he became an assistant dean and in 1990 an associate dean.

He has served on numerous advisory committees within the continuing educa-

tion and summer programs area as well as in the College of Education and Allied Professions. In 1988 he was named Friend of the College for the College of Education and Allied Professions and in 1990 he was honored as Friend of Ottawa County/Port Clinton Schools.

In nominating Thurairatnam for the Ferrari Award, colleagues Suzanne Andrews and Audrey Bricker, both continuing education, described him as "loyal, supportive, dedicated, honest, positive, cooperative, pro-active, meticulous, efficient, effective and intelligent."

As director of off-campus programs, Thurairatnam is responsible for extending the University's educational services to non-traditional students and various professional groups throughout a 25-county service region in northwest Ohio. He coordinates programs with academic departments on campus to offer credit courses at off-campus sites and assists with academic support services for these courses.

According to Andrews and Bricker, Thurairatnam was innovative in implementing the idea of special standing academic status, modular scheduling and special pricing of a series of graduate courses, which has been key to annual growth in both new applications and continuing registrations in the Graduate College.

Thurairatnam is also a productive grants writer, receiving three Eisenhower grants from the Ohio Board of Regents, an Ocean Focus grant from the National Science Foundation and Early Intervention grants from the Ohio Department of Mental Retardation.



Dr. Dante Thurairatnam, associate dean and director of off-campus programs in the Office of Continuing Education and Summer Programs, received the 1991 Ferrari Award from last year's recipient, Jane Schimpf, Food Operations.

He has given recent presentations on Sri Lankan genocide, summer/off-campus programs, enrollment maintenance and cost stabilization.

Andrews and Bricker also cited Thurairatnam's informal and consistent involvement with international students, whom he often helps not only in the University environment but in adjusting to the United States culture as well.

The Ferrari Award winner is chosen, following campus-wide nominations, by a committee of administrative staff. Selection criteria include innovation, initiative and job performance.

Previous award winners in addition to Schimpf have been Cindy Puffer, coordinator of the pharmacy at the Student Health Center; Dr. Richard L. Conrad, director of computer services and telecommunications services; George J. Howick, director of the Management Center; Gregory DeCrane, assistant vice president for student activities; Patrick Fitzgerald, general manager of WBGU-TV; Zola Buford, registration and records; and Dr. Suzanne Crawford, dean of continuing education.

Recipients of the award are given a plaque and a \$400 piece of artwork.

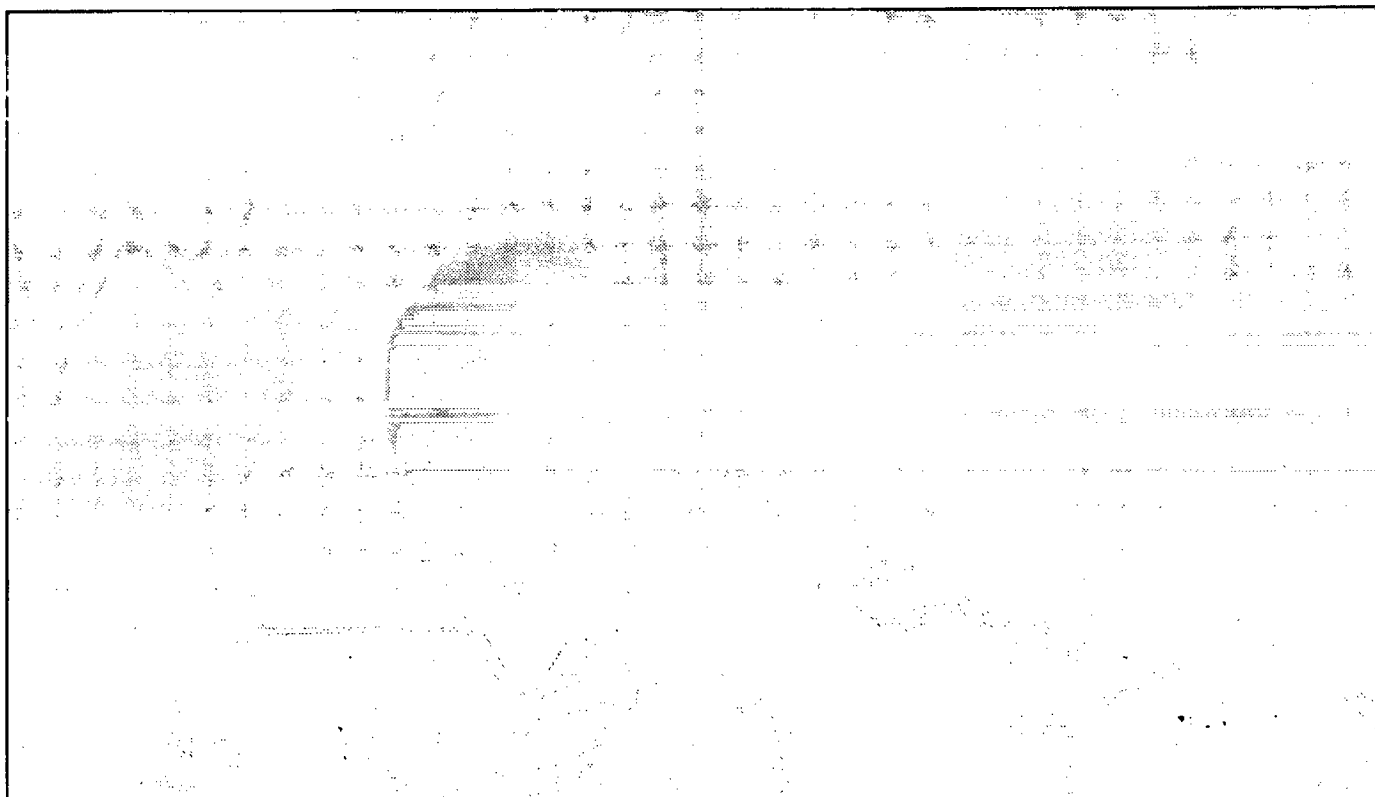

Despite current problems, BGSU in good condition

Despite serious short-term revenue problems with the state portion of the budget, the University overall is in excellent condition, President Olskamp said in his opening day address to faculty and staff Aug. 26.

Olskamp said he is dissatisfied that he will be remembered in University history as the first president since William Jerome to be unable to award salary increases, but he outlined reasons for the University's shortfalls in revenue.

The 1991-92 fiscal budget is \$121 million, he said, approximately the same as the budget approved by the trustees last year. Significant expense reductions had to be made to cover mandated and high priority costs which increased by at least the inflationary rate from last year to this year, Olskamp said.

Expense cuts include reductions in almost all operating budgets, including library and learning resources, planned

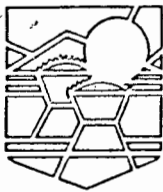

THE MICHAEL R. FERRARI AWARD

Criteria

1. **ELIGIBILITY** - Any person who is a full-time member of the Administrative Staff, i.e. non-faculty contract employee, may be nominated. Nominee must have been an employee for at least one contract year and may not have received the award the previous year. Any nomination that is a nomination from the previous year will need to complete a new nomination application form and be filed by the due date.

2. **NOMINEES** - Must have exhibited exceptional performances and must have demonstrated an emphasis on the human dimension. This means that the nominee exhibits a genuine sensitivity to others by showing an open, caring attitude and is attentive to the growth and development of the University. In addition, the nominee must demonstrate at least one of the following attributes:
 - A. Innovation and Initiative - demonstration of resourcefulness in the work place, including the formulation and implementation of creative new ideas. The emphasis of these ideas should be to improve the work environment, to save time/or money and, in general, to contribute to the better overall efficiency and effectiveness of the University.

 - B. Performance - "above and beyond" that required by the position, e.g., accepting special projects, additional responsibilities such as committee work, giving non-compensable time to effectively complete an assignment, service in professional organizations, or recognition brought to the University through the receipt of grants or through publications.

 - C. Relationship with University Community - The nominee must effectively interact with faculty, staff or students in providing services that promote growth and harmony in their respective departments, areas, etc., as well as the campus. (This would not mandate service on University groups, committees, boards, etc.)

NOTE: The prominence of the University position held by the nominee should not be considered in the selection process.

The following information is meant to give you some background on the Ferrari Award process. Enclosed you find a folder with copies of the correspondence for the 1991 Ferrari Award. All of these letters are on a separate disk (we used Multimate). If you could use this disk we would be happy to share it with you.

The initial meeting of the 1991 Ferrari Award Committee was held on Feb. 11, 1991. The agenda for that meeting is also enclosed.

We basically used the same nomination letter that had been used in the past with a few minor changes. The committee felt that it was very important to keep this letter to one page. There may be a time soon when all of the past winners may not be able to be mentioned on this letter even though this is a nice touch.

A timeline of events was created but I must admit that we were not successful in keeping to the schedule. The rough schedule was as follows:

3/1/91 Mail out nomination letters and forms. Additional nomination forms were also made available in the Bookstore, Union, Personnel and the Faculty Senate Office. Six hundred nomination cover letters, nomination forms and criteria sheets were printed. 500 were label folded and mailed to each Administrative Staff member and 100 were not folded and were distributed to the places listed above.

4/15/91 Deadline for return of nominations

4/22/91 Review of the nominations by the committee.

We decide not to do this as a group but rather the committee members came to my office to review the material and rate the nominees. Copies of the rating form used the past couple of years is attached. The committee had previously agreed to reduce the nominees to four before getting supporting letters for the nominations.

5/1/91 Contact those individuals listed as providing additional references for the final four nominees.

5/15/91 Deadline for return of the supporting letters.

6/1/91 Committee meets as a whole to make the final

selection of the winner of the Ferrari Award.

In reality we did not make the final selection until the beginning of August. While everything did work out okay it would have been better if we could have met our original deadline or at least reached an early July decision. The June deadline was initially established due to vacation conflicts.

Advertising for the award was done in the BG NEWS, the Monitor and of course by the initial cover letter. Copies of all these are enclosed with the information file.

One letter that I did not send out that in retrospect I should have was an acknowledgment of the receipt of the nomination to the nominating individual.

After the final selection is made it is necessary to make arrangements for the plaques (both the individual and permanent plaque) to get engraved. Barry Piersol took care of this in the past and I am sure that he will continue to do so. The Monitor must also be contacted so that an article can be written to coincide with the announcement and so that a picture can be taken for the display in the Union. A letter should also be sent to Dr. Ferrari along with a copy of the Monitor article for his information.

The announcement of the winner of the Ferrari Award is made at the ASC opening reception in the Fall. The decision should be kept confidential except on a need to know basis.

Joyce, hopefully this information will assist you in your duties as chair of the 1992 Ferrari Award Committee. If I can be of any assistance to you or the committee please do not hesitate to call me at 2-2853.

USG orders C

Undergraduate Student Government demanded the resignation of President Kevin Coughlin Monday night in response to a Standards and Procedures recommendation that he step down due to "insensitive" comments made in appointing a vacant senate seat.

However, the resolution may be moot if Coughlin vetoes the bill and the assembly does not gain two-thirds support when it comes up for reapproval.

Coughlin had little reaction to either Standards and Procedures director Derek Dickinson's recommendation or the USG resolu-

tion and said he will not resign.

He maintains his actions can only be reviewed by the president of the University or the Board of Trustees and regards the bill passed by the assembly as an invalid attempt to expel him.

"[The assembly] has no legal, ethical, or constitutional basis for review," he said, "I have already answered to all the charges made against me by Mr. Steeves in the Standards and Procedures hearing."

Jason Jackson, executive assistant to the president, said Coughlin plans to veto the bill and said under the U.S. Constitution, Coughlin does not lose the right to freedom of speech, nor can he be tried twice for the same crime.

ODLC agents were called after a News series "21 — Underaging in Bowling Green" detailed how University students often get served underage at local bars,

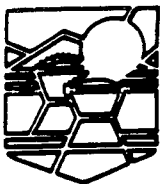



As per our conversation on October 9, I have been conducting a series of fundraising efforts to increase the corpus in the Ferrari Award endowment. Letters went out to members of the Board of Trustees who were in office during Dr. Ferrari's term as president, members of Dr. Ferrari's administrative council, friends of Dr. Ferrari, and the whole of the Administrative Staff of Bowling Green State University. As of today, a total of 56 donors have pledged \$2,825.50 to the Ferrari Award Endowment Fund. Both the amount and the number of donors has been gradually increasing over the past three months.

The increase in the endowment since October still leaves the fund well short of our goal of \$7,500. Thus, I again request that the B.G.S.U. Foundation consider providing matching funds for our first \$2,500 in pledges. The 1991 Ferrari Award Committee met for the first time on January 17, 1992. The Committee reviewed the criteria for the award with no changes suggested.

The selection process was discussed. The committee agreed that the original nomination should be accompanied by three letters of support instead of asking for letters of support for just the finalists at a later time. In the previous year the committee asked for letter of support only for the finalists. This year the committee wished to see the letters of support along with the other materials at the same time.

The committee agreed that, if a person from a previous year is being nominated again, the nominator will submit a new nomination packet.

The committee discussed whether they wanted to see the materials from a previous year if the person had been nominated before. They agreed that they would like to know if the individual had been nominated before. The chair will share that information when the committee meets to review the nominations. The committee will decide at that time whether to look at material from the previous year.

The committee agreed that they did not want to announce the names of those that were nominated and did not receive the award.

The committee discussed whether the actual award of \$400 toward a piece of art work should be discontinued and a cash award be made. There has been some difficulty in finding a piece of art work that the recipient likes. The chair agreed to poll the previous award winners as to whether they appreciated being able to select a piece of art, whether they would have preferred cash and how difficult it has been to make a selection. One committee member suggested commissioning a piece of art that would be given every year. Examples given were a lithography of campus buildings or an piece of glass. The Chair will also research the history of why a piece of art was selected for the award. She will take this issue to the Executive Committee.

A time line was set for the nomination and selection process. The committee will meet to review the nominations on June 2 at 9:30 a.m. pending the agreement of the two absent members.

In the eight years since its formation, the Administrative Staff Council has proven itself not only to be a representative body for all administrative staff, but a staunch supporter of Bowling Green State University as well.

During its early years, ASC realized the importance of committing to academic excellence and in a proactive move established the Administrative Staff Scholarship. At the time we established this fund, the Foundation Board matched the first \$2,500 to assist in endowing the fund. We are grateful to the Board for encouraging employee participation in this manner. The endowment for this award now exceeds \$21,000 and we have been able to make awards to students in each of the last three years. Last year's award in the amount of \$1000 was to Kelly Lynn Sprout, an outstanding pre-med major from Marietta. Our commitment to this fund is continual and our goal is to increase the number of awards each year.

In addition to our scholarship efforts, ASC is currently undertaking the establishment of an endowment fund to support the Michael R. Ferrari Award. The Ferrari Award was established at the request of the Board of Trustees in recognition of the contributions of Dr. Ferrari who served as interim president of Bowling Green State University during 1981 and 1982. ASC was asked to develop the award and since 1983 the Ferrari Award has been presented to an administrative staff member who has given selflessly to the betterment of the University. It is the only recognition award for administrative staff and carries with it a \$400 certificate to be used for the purchase of an original piece of art from the BGSU School of Art. Since its inception, the funding for the award has come out of ASC's operating budget. Since operating budgets have increased only 2 to 3% over the past three years and the activity of ASC has greatly expanded, it has become clear that in order to maintain the award alternative sources of funds are required. Thus the endowment campaign was approved by ASC at its December meeting.

Prior to solicitation from the entire administrative staff, past Ferrari Award recipients and ASC officers contributed over \$1500 in leadership pledges. Our goal is to raise \$7,500 (\$6,500 during the first year) which will allow future increases in the award as dictated by inflation. In our



DRAKE SETS GROUNDBREAKINGS FOR SCIENCE, LAW BUILDINGS

Drake University has scheduled groundbreaking ceremonies on April 6 for a new science and pharmacy building and a new law library. The estimated cost for the two projects is \$18.5 million.

The University's Board of Governors voted Saturday to break ground for a \$8.5 million Law Library and Resource Center and a \$10 million Science and Pharmacy Center at the time of the joint meeting of the university's Board of Governors and Board of Trustees. The Board of Governors also slated groundbreaking ceremonies for the Recreation, Sports & Convocation Center for April 27, the Saturday of the Drake Relays.

Architects have been selected for all three projects, which are scheduled to be completed within two years. Leonard Parker Associates of Minneapolis will design the Law Library and Resource Center. Henningson, Durham & Richardson Inc. of Omaha will design the Science and Pharmacy Center.

RDG Bussard Dikis Inc. of Des Moines is designing the Recreation, Sports and Convocation Center.

At its April meeting, the Board of Governors is expected to set a start date for a fourth major project, the renovation of historic Old Main Auditorium. The Des Moines architectural firm of Baldwin Clause Architects, PC will direct the work.

Another component of Drake's building program is the renovation of Cowles and Carnegie Libraries, which is expected to cost \$3.5 million. About \$1 million has been raised for this project. Computerization of the catalog and circulation systems at both libraries already is under way and will be operational next summer.

As part of the total construction program, the university's Central Plant will be expanded. The architectural firm of Brooks Borg & Skiles of Des Moines will design the expansion.

The major building program is part of the Campaign for Drake, a \$115 million national fundraising effort first announced in October 1989. The Campaign has raised more than \$82 million to date, Drake President Michael R. Ferrari said, noting that approximately \$25 million of that amount is available for the construction projects.

"We're very encouraged by the willingness of the Board of Governors, Board of Trustees, alumni, foundations, corporate leaders and other friends to invest in the future of Drake University," President Ferrari said. "The tremendous support we have received thus far makes it possible for the university to embark on an extensive building program that will serve Drake students and the entire Des Moines area in the coming decade."

Drake has raised \$4.3 million to date for the \$8.5 million Law Library and Resource Center to be built adjacent to Cartwright Hall. Dwight D. Opperman, president and chief executive officer of West Publishing Co. in St. Paul, Minn., chairs the fundraising committee for the building, which will house the Constitutional Law Resource Center, the Agricultural Law Center and the Center for Law-Related Education.

A \$3 million gift from William C. Knapp, chairman of Iowa Realty Co. Inc., has brought the total amount pledged for the 7,000-seat Recreation, Sports & Convocation Center to \$9.7 million. The fundraising committee for the \$12 million facility to be built along Forest Avenue from 25th to 27th streets is chaired by Knapp, James Cownie, former president of Heritage Communications Inc., and David Miller, president of West Des Moines State Bank.

Lawrence C. Weaver, dean emeritus of the University of Minnesota College of Pharmacy, chairs the fundraising committee for the Science and Pharmacy Center to be constructed near Fitch and Ingham Halls. The committee hopes to raise \$3 million for the enrichment of academic programs in the sciences to supplement the \$10 million federal grant awarded to Drake for construction of the new building.



While their funding was appropriate in the early years when ASC was a fledgling organization, current demands on the minimal operating funds of ASC have necessitated a new funding source. In January of 1991, Administrative Staff Council approved the establishment of the Ferrari Endowment through the University Foundation. The initial campaign netted \$2,528 primarily from past officers, award recipients and acquaintances of Dr. Ferrari. This amount represents 33% of the goal of \$7,500, which would allow for the continual funding of the Ferrari Award through interest generated by the corpus.

The next phase of the effort to endow the award is to solicit contributions from employees and those people who knew Mick when he was here. Dr. Philip R. Mason, the Vice President for University Relations recommended that you be included among those contacted at this time. We also have received an indication from Dr. Ferrari of his desire to participate. In addition, we will be reapplying for support from the University Foundation.

I am hopeful that you will consider a donation in the \$100-500 range to the Michael R. Ferrari Endowment which will allow the continuation of a prestigious award which honors both Dr. Ferrari and the outstanding members of E.G.S.U.'s administrative staff.



Thurairatnam wins Ferrari Award for his efforts with off-campus programs, international students

Dr. Dante Thurairatnam, associate dean and director of off-campus programs in the Office of Continuing Education and Summer Programs, is this year's recipient of the Michael R. Ferrari Award.

Thurairatnam received the award at the Aug. 26 opening day reception for administrative staff.

"To be recognized by peers and colleagues is something that is very precious to me. Thank you," Thurairatnam said after receiving the award. Jane Schimpf, last year's Ferrari winner, presented the award.

Administrative Staff Council Chair Josh Kaplan said three runners up for the award were Rich Zera, computer services; Ron Zwiernin, Student Recreation Center; and Jill Carr, housing director.

Created in 1982 by the University Board of Trustees to honor a University administrator who shows a caring attitude in working with faculty, staff and students and who makes outstanding contributions to the University community, the Ferrari Award honors Dr. Michael Ferrari, a longtime Bowling Green administrator who was interim president of the University in 1981-1982. Ferrari is currently president of Drake University in Des Moines, Iowa.

Thurairatnam was a student at the University from 1969-1970, returning to BGSU for a doctoral degree in 1974. He joined the continuing education staff in 1978 as director of off-campus programs and assistant to the vice provost. In 1982 he became an assistant dean and in 1990 an associate dean.

He has served on numerous advisory committees within the continuing educa-

tion and summer programs area as well as in the College of Education and Allied Professions. In 1988 he was named Friend of the College for the College of Education and Allied Professions and in 1990 he was honored as Friend of Ottawa County/Port Clinton Schools.

In nominating Thurairatnam for the Ferrari Award, colleagues Suzanne Andrews and Audrey Bricker, both continuing education, described him as "loyal, supportive, dedicated, honest, positive, cooperative, pro-active, meticulous, efficient, effective and intelligent."

As director of off-campus programs, Thurairatnam is responsible for extending the University's educational services to non-traditional students and various professional groups throughout a 25-county service region in northwest Ohio. He coordinates programs with academic departments on campus to offer credit courses at off-campus sites and assists with academic support services for these courses.

According to Andrews and Bricker, Thurairatnam was innovative in implementing the idea of special standing academic status, modular scheduling and special pricing of a series of graduate courses, which has been key to annual growth in both new applications and continuing registrations in the Graduate College.

Thurairatnam is also a productive grants writer, receiving three Eisenhower grants from the Ohio Board of Regents, an Ocean Focus grant from the National Science Foundation and Early Intervention grants from the Ohio Department of Mental Retardation.



Dr. Dante Thurairatnam, associate dean and director of off-campus programs in the Office of Continuing Education and Summer Programs, received the 1991 Ferrari Award from last year's recipient, Jane Schimpf, Food Operations.

He has given recent presentations on Sri Lankan genocide, summer/off-campus programs, enrollment maintenance and cost stabilization.

Andrews and Bricker also cited Thurairatnam's informal and consistent involvement with international students, whom he often helps not only in the University environment but in adjusting to the United States culture as well.

The Ferrari Award winner is chosen, following campus-wide nominations, by a committee of administrative staff. Selection criteria include innovation, initiative and job performance.

Previous award winners in addition to Schimpf have been Cindy Puffer, coordinator of the pharmacy at the Student Health Center; Dr. Richard L. Conrad, director of computer services and telecommunications services; George J. Howick, director of the Management Center; Gregory DeCrane, assistant vice president for student activities; Patrick Fitzgerald, general manager of WBGU-TV; Zola Buford, registration and records; and Dr. Suzanne Crawford, dean of continuing education.

Recipients of the award are given a plaque and a \$400 piece of artwork.
