Academic Council

Curriculum conversion plans for the colleges of Musical Arts, Business Administration and Education were approved by Academic Council at its meeting March 3.

Richard Eakin, chair of the Task Force on Implementation of the Early Semester Calendar, presented the program conversions, commending the cooperation and effort by the colleges in their attempts to meet the conversion guidelines and timetables.

He noted the programs of the colleges of Musical Arts and Education, as presented, were in complete compliance with the guidelines, and he introduced three exceptions to those guidelines in the business conversion, two of which were approved prior to the endorsement of the total conversion.

Council approved eliminating Accounting 337 and Math 233 from the curriculum in the department of accounting and management information systems, pending endorsement by the appropriate college councils.

Also approved was a change in numbering for BA 303 (Business Communications) to BA 203. A proposed change to renumber Military Science 402 to 202 level was defeated.

non-compliance with conversion guidelines might not become apparent until later dates, Academic Council moved that significant discrepancies discovered between the conversion guidelines and the actual converted curriculum should be referred to the proper college councils for the standard curriculum modification process.

In other business, council moved to table the proposal for a semi-autonomous School of Home Economics until certain issues regarding the proposal can be clarified.

Council also approved a revision in the statement on dual degrees as now published in the Undergraduate Catalog. The revision removes the requirement of a 3.0 grade point average for students desiring to pursue two degree programs in different colleges.

Procedure set for athletic search

Interim President Ferrari has announced the membership of an advisory committee which will guide the search and screening process for a new athletic director to succeed James Lessig, who is leaving the University.

Dr. Marvin Kumler, psychology, faculty representative to the National Collegiate Athletic Association and the Mid-American Conference, will chair the Search and Screening Advisory Committee.

Other members are Myron Chenault, associate vice president of legal, staff and contract relations; James Parker, president of the BGSU Foundation board of directors and a 1957 graduate of the University; Dr. Eldon Snyder, sociology; Faith Jackson, speech communication; Jerry York, head coach, hockey; Carole Huston, associate director, athletics; and undergraduate student athletes Dour Carr (football) and Sara Ringle (volleyball). Savings plan campaign begins

Bowling Green will participate in a U.S. Savings Bond campaign through the remainder of this month.

All faculty, contract and classified staff will receive with their regular March paychecks a brochure which explains the Payroll Savings Plan and a card which authorizes payroll deduction for savings bonds.

The card is to be returned to the payroll office by those interested in the bond program.

Bonds will pay nine percent interest when held to their full eight-year maturity, earn eight and one-half percent when held at least five years, and yield a six percent return after the first year.

Bonds are exempt from state and local income taxes, and reporting of interest for federal tax purposes may be deferred until the bonds are converted to cash, disposed of or reach final maturity.

The advisory committee is seeking nominees or applicants with an advanced degree, a philosophy of athletics that is consistent with the aims and character of the University as a quality residential institution, and demonstrated effectiveness in management or business-related activities and private fund-raising.

The members of the committee will serve as the key advisers to Dr. Ferrari regarding the appointment of a new athletic director and will make arrangements for select faculty and student groups to meet final candidates for the position.

April 12 has been set as the deadline for applications or nominations. The new director is expected to be named later this spring.

Regular memberships are valid immediately; the LiFT ticket will not be valid until March 29, although LiFT members may purchase a \$3 guest pass anytime during the quarter break.

All faculty, contract and classified staff (full- and part-time, permanent and temporary) are eligible to
