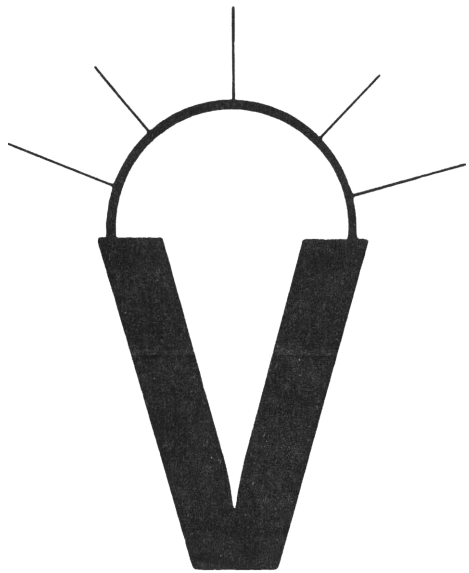

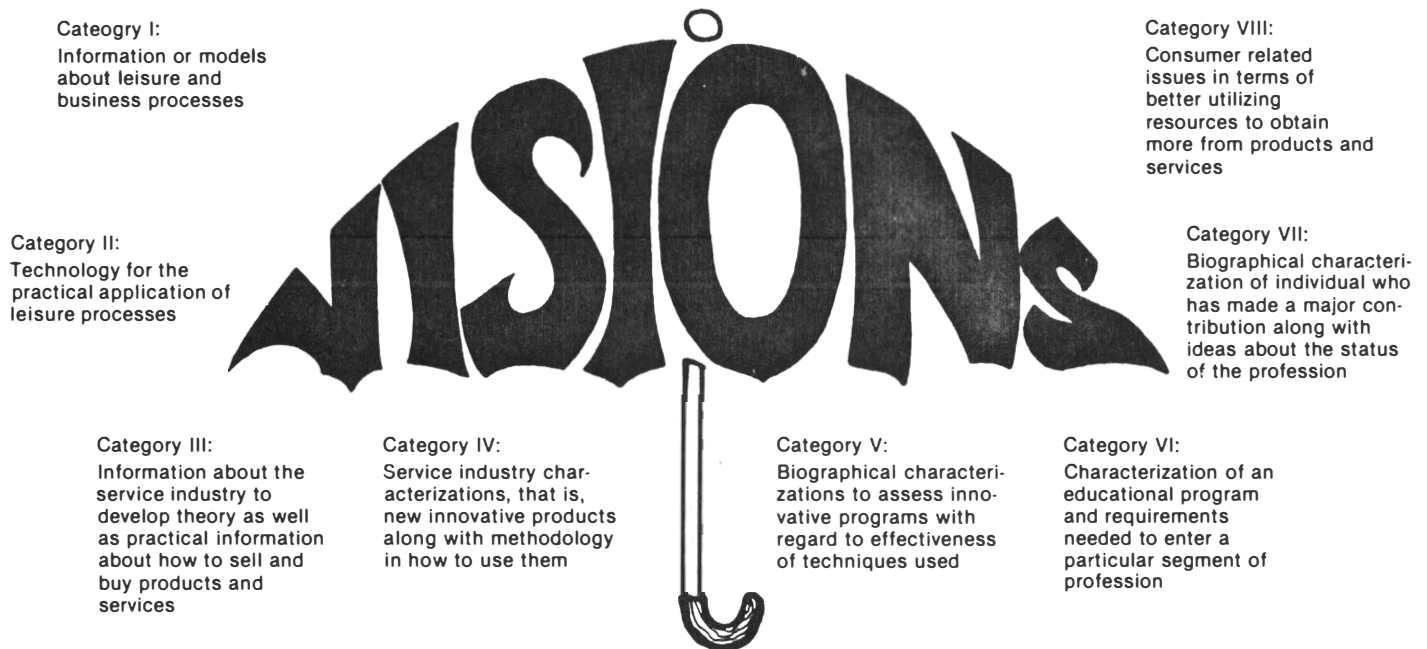

INTRODUCTION

This issue is dedicated to the memory of Mr. William DeCarlo, whose passing was noted in Volume 1 Number 4. There are three foci to this issue: (1) the importance of the private phase of the leisure industry and its relationship to the public sector, (2) the importance of the private sector to the future of the leisure movement, and (3) the responsibility of individuals to develop leisure resources. These topics are those to which Bill dedicated his professional and personal life. He was one of the founding fathers and innovators in the private sector, especially in employee services.
