Marriage to Divorce Ratio, 2018

- In 2018, there were approximately two marriages per every one divorce in the United States (ratio = 2.2), a total of 2,268,129 marriages and 1,050,599 divorces.
- The ratio has remained stable since 2017 when it was also approximately two marriages for every one divorce.

Five Highest and Lowest Marriage to Divorce Ratios, 2018

- All states have a greater number of marriages than divorces. North Dakota (4.5), the District of Columbia (3.9), and Vermont (3.0) were the top three states in the marriage to divorce ratio in 2018. There were at least three marriages per every one divorce in these states.
- The states with the lowest marriage to divorce ratio were Arkansas (1.4), South Dakota (1.5), and West Virginia (1.6).

Figure 1. Women's Marriage to Divorce Ratio, 1970 to 2018







Figure 2. Women's Highest and Lowest Marriage to Divorce Ratios, 2018


State Rankings and Geographic Variation in Marriage to Divorce Ratios, 2018

Figure 3. State Variation in Women's Marriage to Divorce Ratio by Quartile, 2018



- Approximately 42% of states experienced an increase in the marriage to divorce ratio from 2017 to 2018. North Dakota had the largest increase from 2.6 in 2017 to 4.6 in 2018. Rhode Island also had a notable increase from 1.5 to 2.9.
- Over one-third of states (34%) saw a decrease in the marriage to divorce ratio. The District of Columbia experienced the largest decrease, dropping from 5.9 in 2017 to 3.9 in 2018.
- Almost one-quarter (24%) of states had almost the same marriage to divorce ratio in 2018 as they did in 2017. These states were California, Colorado, Connecticut, Florida, Illinois, Nevada, New York, Ohio, Oklahoma, Pennsylvania, South Carolina, and Tennessee.
