June 7, 1943




The minutes of the meeting held on May 24, 1943 were read and approved.

The President presented the contract for the V-12 unit presented by the Navy Negotiating Party now on campus. The contract was studied and discussed at some length. Finally Dr. Johnston moved that it be approved and the proper officials be authorized to sign said contract. Mr. Kershner seconded. Voting yes: Coriell, Rodgers, Johnston, Kershner. Motion carried.

The Board of Trustees of the Bowling Green State University assembled on the above date. The members present were Mr. E. E. Coriell, President; Mr. E. T. Rodgers, Vice President; Dr. H. J. Johnston, Secretary; Mr. Minor Kershner, Treasurer. Commander Dudley White was absent because of service with the United States Naval Forces. President Prout was also in attendance.

The minutes of the meeting held on June 7, 1943 were read and approved.

The President reported at some length on the V-12 unit which took up residence with us on July 1st. He presented the contracts with the Federal Government through the V-12 a second time. It was the judgment of all members of the Board that the contract as entered into last June 7th is fair and equitable to all parties.
