Trustees approve improvement spending

At its Dec. 11 meeting, the Board of Trustees approved nearly \$3 million in capital spending on auxiliary facilities.

Approximately \$2 million will be used to continue ongoing improvements in residence halls on campus, including creating space for a living-learning center on the first floor of Kohl Hall. The plan is that eventually Chapman Community will move into the space.

The package also includes funding for projects such as replacing 10 golf carts and purchasing a range cart and ball picker for BGSU's Forrest Creason Golf Course; buying a new Zamboni for the Ice Arena; continuing to replace seating at Perry Stadium; upgrading the sound system in Memorial Hall; replacing a snow plow truck and purchasing network software for the Student Health Center.

Most of the funding for the projects comes from depreciation reserves for renovation and repair projects that are set aside annually in auxiliary area budgets, according to Christopher Dalton, senior vice president for finance and administration. The exceptions are projects being funded through surplus balances at the golf course and health center.

Trustees also approved the purchase of a parcel of residential property at 1372 E. Wooster Street. The property, which is located on the southwest corner of East Wooster and State streets, could become an important piece in any long-range strategy addressing the entrance to either the campus or the city of Bowling Green, the board was told.

The University will purchase the property for \$141,000 from John and Sheril Shafer with private funds. The five-bedroom house is rented to six students and earns \$1,200 monthly in rent, with an additional \$210 from rental of extra parking spaces.

The board also granted President Ribeau limited authority to purchase property on behalf of the University for the next 18 months to facilitate growth. The property concerned is the quadrant that begins at the intersection of East Wooster Street and South Mercer Road; south on Mercer Road to its end; west to the terminus of Scott Hamilton Drive, continuing west to the intersection of Scott Hamilton

and Manville Street; north to Clough Street; west to Summit Street; north to Frazee Avenue; east to Thurstin Street, south to East Wooster and east to Mercer Road.

The total price of any purchases must not exceed \$750,000.

In other business, President Ribeau was given a 19 percent raise by a unanimous vote, boosting his salary to \$270,000 from \$227,272.

Board president David Bryan, in moving to grant the salary increase, said that Ribeau has accomplished what the presidential search committee had hoped for in uniting the campus. Private giving is up considerably, enrollment has grown, program review is in place and many other goals and objectives have either been achieved or are well under way, he said.

In other action, the board adopted a policy reserving its authority to approve any new names or name changes for all University properties, facilities and academic entities. The policy states that the board may delegate authority to the president for naming

Two fall commencement ceremonies scheduled

The University will hold separate graduation ceremonies for students earning graduate degrees and those earning bachelor's degrees on the main campus. It is the first time BGSU has held a separate commencement for the Graduate College in December.

More than 1,000 students are expected to graduate, including 213 students who will receive advanced degrees.

The Graduate College will hold commencement at 7 p.m. Friday, Dec. 21, in 101 Olscamp Hall. The speaker will be Joe M. Skariah, president of the Graduate Student Senate.

A second-year student in the master of public health program, Skariah works as the house director for Sigma Chi social fraternity on campus. Originally from Garland, Texas, he graduated in 1999 from DePaul University in Chicago, where he

served as student body president.

Undergraduate students will be awarded degrees during ceremonies at 10 a.m. Saturday, Dec. 22, at Anderson Arena in Memorial Hall. The commencement address on

Saturday will be delivered by Timothy S. Fuerst, economics,

who is the winner of the University's 2000 Master Teacher Award.

The Owens-Illinois Professor, Fuerst holds master's and doctoral degrees in economics from the University of Chicago. He first came to BGSU as an instructor during the 1989-90 academic year, then spent three

years teaching at Northwestern University's Kellogg Graduate School of Management. He returned to BGSU in 1993.

A member of the American Economics Association, he is also on the Board of Editors of the American Economic Review and serves as a consultant to the Federal Reserve Bank of Cleveland.
