Approval of Distinguished Research Professor – Dr. Ronald Scherer

No. 36-2014 Mr. Levey moved and Mr. Daley seconded that:

WHEREAS, Dr. Ronald Scherer joined the Bowling Green State University faculty in 1996 as an associate professor in the Department of Communication Disorders;

WHEREAS, Dr. Scherer was promoted to full professor in 2001;

WHEREAS, Dr. Scherer earned a bachelor’s degree in mathematics in 1968 from Kent State University, and master of arts degree in speech pathology and audiology in 1972 from Indiana University, and a Ph.D. in speech science from the University of Iowa in 1981;

WHEREAS, Dr. Scherer has published 150 articles, two books, and almost 200 abstracts accepted at professional meetings;

WHEREAS, Dr. Scherer’s work is cited extensively, and he has delivered numerous keynote addresses around the world;

WHEREAS, Dr. Scherer has received millions of dollars in funding from NIH, with over five million (\$5,000,000) in awards since coming to BGSU;

WHEREAS, Dr. Scherer has developed innovative clinical and research measures of vocal fold movement that are widely used, including a visual measure of glottal adduction, reliable measures of vocal perturbation, and pioneering work on the jaw separation technique to improve speech articulation and voice quality;

WHEREAS, Dr. Scherer serves on the editorial board of *The Journal of Voice*, is Associate Editor of the *Voice and Speech Review Journal*, and is active in many national and international organizations;



WHEREAS, Dr. Scherer has been awarded fellowship status in the International Society of Phonetic Science, the Acoustical Society of America, and the American Speech Language Hearing Association;

WHEREAS, Dr. Scherer has earned high praise from his faculty colleagues and students at B.G.S.U., both in the Department of Communication Disorders and across the University community, and equally high praise from colleagues throughout the nation and world; and

WHEREAS, the nomination of Dr. Ronald Scherer as a Distinguished Research Professor has been supported and endorsed by his department chair, dean, the Distinguished Research Professor Committee, the Council of Deans, and Provost Rodney Rogers.

THEREFORE BE IT RESOLVED, that the Bowling Green State University Board of Trustees approves the naming of Dr. Ronald Scherer as a Distinguished Research Professor.

Authorization to Create the Center for Forensics Science

No. 37-2014 Mr. Levey moved and Ms. Newlove seconded that:

WHEREAS, in 2012, the Ohio legislature appropriated \$11.9 million to Ohio Attorney General Mike DeWine to design and construct a state-of-the-art crime lab and investigations facility for the Ohio Bureau of Criminal Investigation (BCI);

WHEREAS, Ohio Attorney General Mike DeWine selected Bowling Green State University as the site for the new facility;

WHEREAS, on May 3, 2013, the BGSU Board of Trustees authorized the President and the Vice President for Finance and Administration to proceed with the development of the facility and to enter any contractual arrangements that may be necessary to provide campus access and operational services to the crime lab;

WHEREAS, a new Center for Forensics Science will be a product of BGSU’s partnership with BCI;

WHEREAS, the interdisciplinary Center will serve the needs of the professional forensics community and will foster innovative forensic science research, create training opportunities for forensic professionals, and develop innovative academic degree programs in forensic science-related fields; and

WHEREAS, the Center will also serve as a resource for the professional development of forensic science practitioners, as well as develop and coordinate the forensic science academic offerings of BGSU.

THEREFORE, BE IT RESOLVED, that the Board of Trustees authorize the President of Bowling Green State University to work with academic affairs and faculty governance to create the Center for Forensics Science at BGSU.

WHEREAS, the 130th Ohio General Assembly added Ohio Revised Code sec. 3345.81 (Strategic Completion Plan), effective September 29, 2013; and

WHEREAS, ORC 3345.81 requires, by no later than June 30, 2014, the Board of Trustees at each Ohio institution of higher education to adopt an institution-specific strategic completion plan designed to increase the number of degrees and certificates awarded to students; and

WHEREAS, ORC 3345.81 states the plan shall be consistent with the mission and strategic priorities of the institution, include measurable student completion goals, and align with the state's workforce development priorities.

THEREFORE, BE IT RESOLVED, that the Board of Trustees hereby adopts the attached Strategic Completion Plan for Bowling Green State University; and

BE IT FURTHER RESOLVED, that a copy of this plan be forwarded to the Chancellor of the Ohio Board of Regents; and

BE IT FURTHER RESOLVED, that this plan be reviewed and updated at least once every two years, and that a copy of the updated plan be provided to the Chancellor upon adoption.

#### **FINANCIAL AFFAIRS/FACILITIES COMMITTEE**

Mr. Primrose reported that the Financial Affairs/Facilities Committee had met that morning and considered several action and information items.

#### Approval of Bowling Green State University Firelands Campus – Pump Station Easement

No. 39-2014 Mr. Primrose moved and Ms. Morrison seconded that:

WHEREAS, the Bowling Green State University Firelands Campus is located in Erie County, Ohio and the Campus' water and sewer services are supported by infrastructure provided by Erie County; and

WHEREAS, Erie County has informed BGSU that it wants to make improvements to various water and sewer installations in the County and these proposed improvements require BGSU to give the County an easement that is necessary for the County to upgrade the water booster pump station on the BGSU Firelands Campus; and

WHEREAS, it has been determined that the proposed upgrade to the water service supports overall development for the County as well as an upgrade to the service for the Campus; and

WHEREAS, it has also been determined that the proposed upgrade by Erie County will eliminate the need to install a separate fire pump as part of the addition to Firelands' North Building for the upcoming Allied Health and Sciences Project, saving the project approximately \$100,000 - \$150,000; and

WHEREAS, Erie County wishes to proceed with this project during the summer of 2014 in order to complete the improvements and meet the projected schedule for the Allied Health and Sciences Building;

NOW, THEREFORE BE IT RESOLVED, that Bowling Green State University agrees to grant to Erie County an easement to install, operate, maintain and repair a water booster pump station on the BGSU Firelands Campus for a term of 25 years for the benefit of the University. The University President and the Vice President for Finance and Administration, or either of them, are delegated such authority as may be necessary to execute and deliver any such future Easement Agreements to Erie County, and to take the actions necessary to carry out the transactions contemplated therein and to have performed on behalf of the University all of the University's obligations under such Easement Agreements after such Agreements have been reviewed and approved by the appropriate University departments, including the University Office of General Counsel.

## REPORTS - CONSTITUENT REPRESENTATIVES

### BGSU Firelands, John Britton

Mr. Britton expressed appreciation to President Mazey and staff members that assisted with enhancements to commencement exercises on the Firelands campus. The ceremony at Firelands will celebrate 447 associate degree candidates and more than 25 bachelor's degree candidates. Associate degrees awarded this year almost double the number from last year as a result of the efforts of Academic and Student Services. Several high school students will also be participating in the commencement ceremony. These students take classes at BGSU Firelands through the college Access program and each year a handful of those students have enough credit hours to earn an associates degree.
