#### Approval of Columbia Gas of Ohio Easement Renewal

No. 3-2017

WHEREAS, the Ohio General Services Division, Office of Real Estate and Planning, has identified a need to renew a utility easement that had been granted to the Columbia Gas of Ohio, Inc. (Exhibit A); and

WHEREAS; the original easement was granted in 1989 during the development of the Research Enterprise Park and supported the installation, construction, reconstruction, use, operation, maintenance, repair, replacement, removal, servicing and improvement of a certain gas pipeline along the easement area; and

WHEREAS; the State of Ohio wishes to proceed with renewing the existing easement in accordance with their standards for a term of twenty-five (25) years; and

WHEREAS, the final easement documentation (including the final survey, legal descriptions and plats) was completed by the Ohio General Services Division, Office of Real Estate and Planning;

NOW, THEREFORE BE IT RESOLVED, that the Bowling Green State University Board of Trustees authorize and directs the President and the Vice President for Finance and Administration, or either of them, to execute and deliver all requisite documents necessary to renew this easement and to take any other action deemed necessary or as determined and advised by the University’s Vice President and General Counsel to carry out the easement renewal contemplated in this action and to perform on behalf of the University, or cause to be performed on behalf of the University, all of the University’s obligations associated with renewing this easement.

Approval of Ice Arena – Ice Plant and Floor Replacement

No. 4-2017

WHEREAS, the University Ice Arena was built in 1967, and has served as home to the University's Varsity Hockey team and community youth hockey; and

WHEREAS, the University's students have utilized the rink for both academic and non-academic purposes; and

WHEREAS, the most recent significant renovations occurred in 2009 through 2011 and included upgrades to the building envelope, roof, lighting, humidification system, and replacement of the ice plant compressors; and

WHEREAS, renewal and replacement funds in the amount of \$2,712,568 will be provided to fund the project; and should any privately donated funds become available, the need for renewal and replacement funds will be reduced; and

WHEREAS, the design, bidding, and construction will follow all applicable state laws and regulations;

NOW, THEREFORE BE IT RESOLVED, that the Bowling Green State University Board of Trustees hereby authorizes the Vice President for Finance and Administration to proceed with the project as described above.

Approval of Sale of Certain Property in City of Bowling Green – 129 South Prospect

No. 5-2017

WHEREAS, the University owns a 2,840 square foot house located off-campus at 129 South Prospect which has been used for many years to house a Greek sorority; and

WHEREAS, the house is no longer in use by the sorority since the completion of the Greek Village; and

WHEREAS, the house is not desirable to retain and utilize for transitional rental housing purposes as upgrades would be extensive and costly; and

WHEREAS, the market value per the appraisals is \$180,000;

NOW, THEREFORE BE IT RESOLVED, that the Board of Trustees authorize and direct the University President and the Vice President for Finance and Administration, or either of them, to execute and deliver all requisite documents necessary to carry out the transaction contemplated in this action and to perform on behalf of the University, or cause to be performed on behalf of the University, all of the University's obligations associated with the sale of the 129 S. Prospect property at the \$180,000 appraised value. Further, the sale transaction shall conform to applicable laws and the authorizations as determined by the University's Vice President and General Counsel and the Attorney General of the State of Ohio.

Approval of East Campus Electrical Load Center and Centrex Electrical Load Center Replacements

No. 6-2017

WHEREAS, funding in the amount of \$9,424,200 has been identified (\$7,164,200 from the FY2017-2018 State Capital Bill; \$746,000 from Residence Life Renewal and Replacement reserves, and \$1,514,000 from future long-term debt); and

WHEREAS, the proposed project is part of an ongoing, phased, full campus electrical modernization; and

WHEREAS, this phase of the proposed project includes removing four existing, centrally located electrical load centers and installing new electrical distribution feeders and transformers to each of nine buildings; and

WHEREAS, the project also provides for converting power service from 4.16kV to 12.47kV; and

WHEREAS, the East Campus Load Center work will support the Fine Arts Building, Mileti Alumni Center, Conklin Hall, Harshman and Kreisler Quadrangles, the Ice Arena, and Perry Stadium, and related peripherals; and

WHEREAS, the Centrex Load Center work will support the Business Administration Building, Olscamp Hall, the Education Building, Memorial Hall and East Hall; and

WHEREAS, the design, bidding, and construction will follow all applicable state laws and regulations;

NOW, THEREFORE BE IT RESOLVED, that the Bowling Green State University Board of Trustees hereby authorizes the Vice President for Finance and Administration to proceed with the project as described above.

#### Approval of Moore Musical Arts Center Ductwork Replacement

##### No. 7-2017

WHEREAS, funding in the amount of \$3,051,000 has been identified from the FY2017-2018 State Capital bill; and

WHEREAS, the work scope will include the replacement of the deteriorated fiberglass supply air duct board, internally lined insulated sheet metal ductwork and sound traps/silencers with a new cotton type internally lined insulated sheet metal ductwork; and

WHEREAS, the nature of this upgrade will require building evacuation of all occupants from early May to the end of July 2017; and

WHEREAS, the design, bidding, and construction will follow all applicable state laws and regulations;

NOW, THEREFORE BE IT RESOLVED, that the Bowling Green State University Board of Trustees hereby authorizes the Vice President for Finance and Administration to proceed with the project as described above.

#### Approval of Change in Name for the Dallas-Hamilton Center for Entrepreneurial Leadership

The Bowling Green State University Board of Trustees approves the change in name of the Dallas-Hamilton Center for Entrepreneurial Leadership to the Scott and Tracie Hamilton Center for Entrepreneurial Leadership.

WHEREAS, as a student at BGSU, Mr. Stanton was involved with Air Force ROTC, the Arnold Air Society, and the Flying Club;

WHEREAS, with a particular interest in audio recording, Mr. Stanton also worked at WBGU and "spun records" on campus; and

WHEREAS, Ms. Strebe taught school in Plymouth and Livonia, Michigan, for 35 years;

WHEREAS, as a student at BGSU, Ms. Strebe was a member of the Association for Childhood Education, Future Teachers Association, Kappa Delta Pi education honorary, Treble Clef women’s singing group, and the Usherette Club;

WHEREAS, in recognition of education she received, Ms. Strebe established the Muriel Hutchinson Strebe Scholarship and the Muriel Hutchinson Strebe Book Award at BGSU;

WHEREAS, BGSU will be the beneficiary of Ms. Strebe’s estate;

WHEREAS, the total for the estate is more than \$1 million;

WHEREAS, Room 201 of the Education Building has been identified as the classroom to be named.

NOW, THEREFORE, BE IT RESOLVED, in recognition of Ms. Muriel Hutchinson Strebe’s long and distinguished career in education and her dedication and generosity to Bowling Green State University, the Bowling Green State University Board of Trustees approves the naming of Room 201 in the Education Building as the “Muriel Hutchinson Strebe Classroom”.

The Board Secretary conducted a roll call vote with the following results: Voting “yes” – Mr. Daley, Mr. Keller, Mr. Levey, Ms. Montgomery, Ms. Morrison, Ms. Newlove, Mr. O’Brien, and Dr. Ross. The motion was approved with eight affirmative votes.

Discussion items on the agenda included a presentation from external auditors from Plante Moran; an annual security update from John Ellinger, Chief Information Officer and Matt Haschak, Director of IT Security; the 2017 Risk Assessment, presented by Jim Lambert, Director of Internal Audit; a summary of fraud hotline statistics, a report on current audit findings and a correction action update, and an Audit Committee training topic.

**DEVELOPMENT AND INVESTMENT COMMITTEE**

Committee Chair, Mr. Keller reported that the only action item before the committee was the approval of minutes from the May 5, 2016, meeting.

Mr. Keller reported that discussion items on the agenda included a review of market performance and July 31, 2016, investment schedule, a development and campaign update from Vice President Shea McGrew and a proposed amendment to the Board of Trustees Bylaws.

## **GOVERNANCE COMMITTEE**

Mr. Nyberg stated that the Governance Committee has one being presented for action by the Board. He noted that for the past few years the Joint Development and Investment Committee has been working with members of the Foundation Board on matters pertaining to both investment and development. To better dedicate work to these important areas, the Governance Committee is proposing that the Joint Development and Investment Committee be split into two committees.

### Approval of Amendment to Board of Trustees Bylaws

No. 12-2017 Mr. Levey moved and Ms. Montgomery seconded that:

WHEREAS, in Article IV, Section 7, of its Bylaws, Bowling Green State University's Board of Trustees ("the Board") defines the composition and charge of its Joint Development and Investment Committee;

WEHREAS, the Board has determined that it needs to amend its Bylaws and create separate committees dedicated to Investment and Development functions: The Joint Investment Committee (JIC) and the Joint Development Committee (JDC);

WHEREAS, the new committees will be better able to address current and future needs in the areas of investment and development; and

WHEREAS, consistent with present practice, JIC and JDC will work with members of the Bowling Green State University Foundation.

NOW, THEREFORE, BE IT RESOLVED, that the Bowling Green State University Board of Trustees hereby approves the amendments to Article IV of the Bylaws of the Board of Trustees.

Chair Levey asked for a voice vote. The motion was approved.

## **REPORTS - CONSTITUENT REPRESENTATIVES**

### BGSU Firelands, Tom Tucker

Ms. Galan provided a recap of the spring banquet held on April 19, 2016, that included networking and a silent auction to benefit student scholarships.
