Approval of Article 38 of Collective Bargaining Agreement with BGSU-Faculty Association and Bowling Green State University – Winter Session

No. 3-2018

WHEREAS, at its May 6, 2016, meeting, the Bowling Green State University (BGSU) Board of Trustees approved Collective Bargaining Agreement with the Bowling Green State University Faculty Association – Contract Periods July 1, 2016 – July 1, 2019;

WHEREAS, at its February 17, 2017, meeting, the BGSU Board of Trustees approved the change in the academic calendar from 16-week academic year semesters to 15-week academic year semesters with an intersession, and authorized the President and/or her designees to commence with operational planning for implementation no earlier than Fall 2018;

WHEREAS, on February 28, 2017, the BGSU Faculty Association (BGSU-FA) issued a demand to bargain over the proposed intersession term;

WHEREAS, negotiating teams for the Administration and BGSU-FA initiated bargaining on June 16, 2017;

WHEREAS, Using Interest-Based Bargaining practices, a tentative agreement between the Parties was signed on August 21, 2017;

WHEREAS, the tentative agreement provides for the addition of a new article, Article 38: Winter Session, to the 2016-2019 Collective Bargaining Agreement between the University and the BGSU Faculty Association;

WHEREAS, the proposed tentative agreement is attached to and included in this resolution;

WHEREAS, the BGSU-FA ratified the proposed language for Article 38: Winter Session on September 11, 2017;

WHEREAS, the Board has reviewed the proposed tentative agreement and has determined that it is both reasonable and equitable to the parties; and

WHEREAS, the Board expresses its appreciation to all concerned parties for their efforts to bring this matter to a successful resolution.

NOW, THEREFORE BE IT RESOLVED, that pursuant to its authorities under Chapter 3341 and Chapter 4117 of the Ohio Revised Code, the attached Article 38: Winter Session, incorporated into the 2016-

2019 Collective Bargaining Agreement between the University and the BGSU Faculty Association, is hereby approved and ratified by the Board; and

BE IT FURTHER RESOLVED, that the appropriate officers and managers of the University are hereby authorized and directed to execute and to deliver the amended Collective Bargaining Agreement to the lawful representatives of the BGSU-FA and, upon full execution of the same, to timely deliver a copy of the Agreement to the State Employment Relations Board; and

BE IT FURTHER RESOLVED, that the Board hereby ratifies and confirms any and all actions taken by the officers and managers of the University and their representatives prior to the date of this Resolution to negotiate Article 38 of the Collective Bargaining Agreement and to present it to the Board for its consideration.

Approval of Proposal to Create the School of the Built Environment

No. 4-2018

WHEREAS, the College of Technology, Architecture, and Applied Engineering contains four departments, two of which are the Department of Architecture and Environmental Design (AED) and Department of Construction Management (CM);

WHEREAS, the departments as separate entities have not engaged in joint research, scholarship, and grant opportunities as much as they could in a common structural unit;

WHEREAS, reorganization of AED and CM into one School of the Built Environment provides additional opportunities for collaborative teaching, research, and service;

WHEREAS, the School of the Built Environment will take advantage of management effectiveness potential;

WHEREAS, the School will activate synergies among interdisciplinary academic areas to set a competitive advantage in Northwest Ohio and the region in terms of student learning, research and scholarship, and service and community engagement;

WHEREAS, the School of the Built Environment is unique in purpose and structure among Ohio universities and the universities in the region;

WHEREAS, the School would be led by a school director and consist of two departments – AED and CM – led by department chairs;

WHEREAS, the continuing department status of AED and CM fulfills requirements for their respective accrediting agencies; and

WHEREAS, the proposal to create the School received strong support from Undergraduate Council, Graduate Council, Fiscal Affairs Advisory Committee, and the Faculty Senate Committee on Academic Affairs.

NOW, THEREFORE BE IT RESOLVED, that the Bowling Green State University Board of Trustees approves the proposal to create the School of the Built Environment in the College of Technology, Architecture, and Applied Engineering.

WHEREAS, Mr. Schmidthorst committed additional funds for upgrades to the Athletics’ “Walk of Fame and History” and the weight room at the Sebo Center, ensuring that the history of BGSU Athletics will be displayed appropriately and attractively so that visitors to the Stroh Center will be able to see the significant accomplishments of student-athletes; and

WHEREAS, in September 2017, Bowling Green State University's Senate Executive Committee approved the nomination of Mr. Schmidthorst for an honorary degree.

WHEREAS, House Bill 64 (Section 369.550) requires each institution's board of trustees to review and approve the institution's FY 2017 Affordability and Efficiency Report and submit the approved report by October 13, 2017; and

NOW, THEREFORE BE IT RESOLVED, that the Bowling Green State University Board of Trustees approves BGSU's FY 2017 Affordability and Efficiency Report as described in the attached document.

Approval of Increase in Authority to Invest in Real Estate

WHEREAS, the University has opportunity from time to time to consider acquisition of real property near or adjacent to campus; and

WHEREAS, the University's scheduled Board meetings do not always coincide with or provide the ability to timely respond to real property acquisition opportunities; and

WHEREAS, the Board previously authorized at their May 5, 2017 meeting a limited authority to invest in real estate in an amount not to exceed \$1 million between the period of July 1, 2017 through June 30, 2019; and

WHEREAS, since July 1, 2017, the University or Centennial Falcon Properties, Inc. acting to benefit BGSU have entered into multiple real estate purchase agreements totaling \$836,000;

NOW, THEREFORE BE IT RESOLVED, that the Bowling Green State University Board of Trustees hereby grants an additional limited authority of \$1 million to invest in real property near or adjacent to campus

to the Vice President for Finance and Administration with concurrence of the President up to an aggregate of \$2 million during the period of July 1, 2017 through June 30, 2019.

Approval of Additional Enabling Projects for the Maurer Center Renovation

WHEREAS, the Board of Trustees approved an initial \$5,722,780 (to be provided from private donor funds and future long-term debt) at the February 17, 2017 to begin architecture/engineering and preconstruction advisor services work on the Maurer Center (formerly Hanna Hall); and

WHEREAS, the design and pre-construction services to be provided included necessary professional design, technical consultants, LEED certification and energy modeling, surveys, prototyping, and relocation of a fiber optic duct bank work was necessary to allow for the planning related to the renovation and future construction of the Maurer Center; and

WHEREAS, it has been determined that additional planning and project work will be necessary prior to the renovation and future construction of the Maurer Center including relocation of existing chilled water and gas lines currently located under Parking Lot A (east side of Maurer Center), design, construction and furnishing of a prototype space, and contracting for the remaining portion of the project's pre-construction advisor services contract; and

WHEREAS, \$1,450,000 from private donor funds and future long term debt has been identified; and

WHEREAS, upon completion of the design and pre-construction work, a detailed project proposal will be brought back to the Board of Trustees for consideration; and

WHEREAS, the design, bidding, and construction will follow all applicable state laws and regulations;

NOW, THEREFORE BE IT RESOLVED, that the Bowling Green State University Board of Trustees hereby authorizes the Vice President for Finance and Administration to proceed with the project as described above.

Approval of Six-Year Capital Plan for Fiscal Years 2019-2024

WHEREAS, the Ohio Department of Higher Education (ODHE) has requested that each campus of public higher education in Ohio prepare a capital plan for fiscal years 2019-2024; and

WHEREAS, the plan advanced to the ODHE is to be consistent with the guidelines and public policy objectives described by the ODHE; and

WHEREAS, the exact amount of the formula-driven capital funding will not be known until the funds are actually appropriated; and

WHEREAS, Bowling Green State University has identified broad categories consistent with the historical priorities of ODHE with specific capital projects within each category for each biennium of the six-year plan; and

WHEREAS, the projects being recommended are consistent with both Campus Master Plans and are considered necessary to address existing and anticipated academic program needs and maintaining the campus infrastructure;

NOW, THEREFORE BE IT RESOLVED, that the Bowling Green State University Board of Trustees approves the Six-Year Capital Plan for Fiscal Years 2019-2024 contingent upon adequate funding being appropriated or provided federally or locally to undertake the projects at the level of funding specified.
