## **MINUTES**

Board of Trustees Bowling Green State University May 15, 2020

Notice having been given in accordance with the Board of Trustees Bylaws, and per a March 13, 2020, statement issued by Ohio Attorney General, Dave Yost, the following members of The Bowling Green State University Board of Trustees met electronically for a regularly scheduled meeting on May 15, 2020: Daniel Keller, Chair; Marilyn Eisele, Leah Fishman, Drew Forhan, Linda Forte, Ava Harter, Betty Montgomery, Bruce Nyberg, David O'Brien, Geoff Radbill, Dr. Richard Ross, Remington Schneider, Amy Shore, and Howard Traul.

Mr. Keller called the meeting to order at 9:05 a.m. The Board Secretary called the roll and announced that a quorum was present (seven trustees).

Mr. Keller noted that, pursuant to a statement issued by Ohio Attorney General, Dave Yost, public university boards of trustees are permitted to meet electronically in order to practice appropriate physical distancing in this time of a COVID-19 declared emergency in Ohio. Trustees, President Rogers, members of the President's Cabinet, and members of the BGSU community are able to participate in the meeting via live-stream. Mr. Keller thanked those who joined the meeting. He then introduced President Rogers.

President Rogers offered brief opening remarks, stating some assumptions the university was making as it engages in budget planning for the upcoming fiscal year. As previously reported, Governor DeWine has announced a 20% reduction in state share of instruction. Further, based on what we know today, BGSU is projecting a 6-7% decline in enrollment.

Chair Keller asked BGSU General Counsel, Dr. Natalie Jackson, to review for the Board the general scope and purposes allowed for executive sessions under Ohio's Open Meetings Laws. Dr. Jackson reported that, of the nine permitted reasons for Ohio's public bodies to go into executive session, six apply to institutions of higher education:

- 1. Personnel decisions related to appointment, employment, compensation, evaluation, discipline, and dismissal;
- 2. Purchase or sale of property;
- 3. Discussion of pending litigation;
- 4. Preparation for, conduct of, or review of collective bargaining materials
- 5. Discussion of matters deemed confidential by other provisions of law; and
- 6. Security arrangements for response to emergency.

Chair Keller thanked Dr. Jackson.

#### **EXECUTIVE SESSION**

Mr. Keller made a motion – pursuant to the provisions of the Ohio Open Meetings Act, Ohio Revised Code section 121.22 – to enter into executive session to discuss (1) employment, dismissal, and compensation of public employees; and (2) collective bargaining matters. Ms. Harter seconded. Roll call was taken and the motion was approved.

At the conclusion of the executive session, Mr. Keller reconvened the meeting and announced that the Board met in executive session, at which no action was taken. Roll call was taken and a quorum was noted with all trustees present.

At 11:08 a.m., Mr. Forhan made a motion to come out of executive session. Mr. O'Brien seconded. Roll call was taken and the motion was approved.

## PRESIDENT'S REPORT

President Rogers began his report by reviewing the key imperatives of BGSU's strategic plan, noting the importance of the plan under the circumstances. President Rogers then thanks the faculty, staff, and students for their work transferring teaching and learning activities online for the second half of spring semester. In support of students, refunds were issued to those who moved out of the residence halls and over \$3 million was raised for a student emergency fund. Summer 2020 courses will be entirely online. Planning for Fall 2020 continues with two task forces working diligently on course and program planning, as well as other university offices and divisions. President Rogers reported that further updates will be provided at the June meeting. On budget planning, several short-term and long-term considerations must be made, including very tough decisions to eliminate some faculty and staff positions. President Rogers offered condolences to the family of Dr. Neil Englehart, Chair of the Department of Political Science, who passed away suddenly in early May. He noted Dr. Englehart's many years of service and accomplishment at BGSU and offered a special mention to Dr. Englehart's spouse, Dr. Melissa Miller, professor of political science. Finally, President Rogers congratulated those faculty earning promotion and/or tenure and the 2523 students who will be graduating in May.

Vice President for University Advancement, Pam Conlin, presented a brief Advancement update, highlighting fundraising activities, milestones, and timelines and events for the remainder of the Changing Lives for the World Campaign.

Approval of Olscamp Roof Repair and Replacement

No. 38-2020 Ms. Montgomery moved and Mr. O'Brien seconded that:

WHEREAS, funding in the amount of \$1,597,337 from deferred maintenance reserves and \$142,463 from insurance reimbursement has been identified; and

WHEREAS, the proposed project includes a planned replacement of the building roof, replacing the failed roof membrane, addressing all roof details at expansion joints, parapet walls, coping and roof-mounted equipment and replacing the skylights,

WHEREAS, the design, bidding, and construction will follow all applicable state laws and regulations;

NOW, THEREFORE BE IT RESOLVED, that the Bowling Green State University Board of Trustees hereby authorizes the Vice President for Finance and Administration to proceed with the Olscamp Roof Replacement as described above.

Approval of Special Graduate Out of State Fee Waiver for FY 2021

No. 39-2020 Ms. Shore moved and Ms. Harter seconded that:

WHEREAS, all public universities in Ohio have been asked to consider providing a special graduate out of state fee waiver for FY 2021, effective for the fall semester for certain degree-seeking graduate students who have completed a bachelor's or master's degree in Ohio from an Ohio institution; and

WHEREAS, Pursuant to the continued authority in §381.170 of Am. Sub. H.B. 166 and Directive 2009-011, Bowling Green State University will submit a request to the Chancellor of the Ohio Department of Higher Education authorizing the special graduate out of state fee waiver for FY 2021 following approval by the University's Board of Trustees; and

WHEREAS, BGSU has identified those academic programs which will be excluded from eligibility for the out of state graduate fee waiver request including 1) all Master of Business Administration programs and 2) all graduate programs that are delivered as part of BGSU's eCampus/Distance or Extended Campus based on one or more of the following reasons: 1) the program targets a professional audience; 2) the program is a highly competitive program with high demand; or 3) the program already receives significantly reduced non-resident fees; and

WHEREAS, the goal of the proposed revision to the out of state graduate fee waiver is to incentivize non-resident students who have earned a bachelor's or master's degree in Ohio from an Ohio institution to stay in Ohio and earn a graduate degree. BGSU is committed to attracting a diverse pool of graduate students and this incentive is one important part of that commitment; and

WHEREAS, the revisions proposed include:

Current non-resident surcharge Proposed non-resident surcharge

1-12 credits \$ 332.85 per credit \$ 1.00 per credit 12-18 credits \$ 3994.20 maximum \$ 12.00 maximum

Approval of Special Fee Waiver for Bowling Green Campus General Fee for FY 2021

- WHEREAS, out of an abundance of caution, and in light of the uncertainties caused by the COVID-19 virus, Bowling Green State University has determined that the 2020 summer semester (FY 2021) will be delivered in a remote format; and
- WHEREAS, the current Bowling Green campus general fee normally supports numerous student and student- service related uses and activities such as Inter-collegiate Athletics, the Student Rec Center, Bowen-Thompson Student Union, student organizations and activities in addition to the debt service, insurance and other facility costs associated with the general fee supported auxiliaries; and
- WHEREAS, we anticipate that some of the student-service related uses and activities will be significantly less in a remote learning environment while others will be largely unchanged (e.g., debt service, insurance, campus technology infrastructure, etc.); and
- WHEREAS, we seek to balance the University's need to ensure that we continue to meet our fixed expense obligations in general fee auxiliaries with the University's desire to fairly assess students for general fee-supported services; and
- WHEREAS, a 50 percent waiver of the current, applicable general fees for all full time Bowling Green campus student groups (i.e., continuing undergraduates, all Falcon Tuition Guarantee cohorts, graduate) effective with the summer 2020 semester (FY 2021) is proposed, and

- WHEREAS, continuing Bowling Green campus students currently are assessed \$63.50 per student credit hour (or \$762 for a full time student) as a general fee; and
- WHEREAS, the proposed 50 percent waiver would remain in effect for the fall 2020 and spring 2021 semester to the extent the University continues to function in a fully remote manner; and
- WHEREAS, the 50 percent waiver would cease for any semester in FY 2021 in which fully remote instruction ceases; and in any semester in which the University provides a fully hybrid instructional delivery (i.e., partial face to face and partial remote delivery), a 25 percent fee waiver reduction would be awarded; and
- WHEREAS, the waiver would cease automatically at the conclusion of spring semester 2021; any extension would require a future Board of Trustees' authorization for a subsequent period and fiscal year; and
- WHEREAS, this proposed general fee waiver request does not apply to the separate Stroh Center facility fee which was approved by a vote of the Bowling Green campus student body in 2010 and is solely dedicated to providing debt service on the Stroh Center;
- NOW, THEREFORE BE IT RESOLVED, that the Bowling Green State University Board of Trustees approves the 50 percent special fee waiver for Bowling Green Campus General Fee for FY 2021 as more fully described and presented in the attached background effective for the summer 2020 semester on the Bowling Green Campus.

The Board Secretary conducted a roll call vote with the following results: Voting "yes" – Ms. Eisele, Mr. Forhan, Ms. Harter, Mr. Keller, Ms. Montgomery, Mr. O'Brien, Dr. Ross, Ms. Shore, and Mr. Traul. The motion was approved, as amended, with nine affirmative votes.

Ms. Stoll provided brief presentations on four informational items: Annual Update – Advisory Retirement Plan Committee Progress; Market Performance and University Investment Schedule through March 31, 2020; Capital Projects Status Report through March 31 2020; and E&G Expenditure Report through March 31, 2020.

- WHEREAS, Mr. George Miller, of Chicago, Illinois, earned a bachelor of science in Business Administration and Advertising in 1973 from Bowling Green State University and a master's degree in Health Services Administration in 1997 from Central Michigan University;
- WHEREAS, as a student, Mr. Miller was a member and president of Omega Psi Phi fraternity; a member of InterFraternity Council, Antaeans Greek Leadership honorary, and the Black Student Union; and vice president of the BGSU Student Body;
- WHEREAS, since 2017, Mr. Miller is President and CEO of Loretto Hospital, and founder of Hospital Healthcare Connect;
- WHEREAS, Loretto Hospital is a non-profit, safety net hospital serving the Austin Community on the West Side of Chicago;

- WHEREAS, previously, Mr. Miller was President and CEO of Healthcare for CommUnityCare Health Centers in Austin, Texas; CEO of Okmulgee Memorial Hospital in Okmulgee, Oklahoma; President/CEO of First Diversity Healthcare Group; and Regional President/CEO of Community Mercy Health Partners located in Springfield, Ohio;
- WHEREAS, from May 2008 August 2014, he served under Presidents George W. Bush, and Barack Obama as Commissioner with the Medicare Payment Advisory Commission (MedPAC), serving the Washington, DC area; and
- WHEREAS, he has been an Adjunct Professor at Central Michigan University since January 1998, and teaches graduate courses in the master's program for health services administration.
- NOW THEREFORE BE IT RESOLVED that the Bowling Green State University Board of Trustees, in recognition of Mr. George Miller's professional accomplishments and contributions to the Bowling Green State University community, appoint Mr. Miller to a three-year term as a National Trustee, effective May 17, 2020.
